A RESOLUTION

1 Commemorating the 50th anniversary of the incorporation of the
2 Borough of Seven Springs in Somerset and Fayette Counties.

3 WHEREAS, The Borough of Seven Springs was officially
4 incorporated in Somerset and Fayette Counties on January 1,
5 1964; and

6 WHEREAS, Seven Springs has the distinction of being, in
7 elevation, the highest borough in Pennsylvania at 2,540 feet;
8 and

9 WHEREAS, The residents of Seven Springs, along with resort
10 partners, have a long tradition of local, regional, national and
11 international volunteerism and philanthropy to organizations
12 serving the sick and poor and innumerable other civic,
13 educational, charitable and religious organizations; and

14 WHEREAS, Seven Springs has recently worked to improve its
15 environmental stewardship in all operations and facilities; and

1 WHEREAS, Seven Springs is a tremendous regional resort
2 destination attracting over one million visitors annually and
3 generating significant tax revenue for State and local
4 government; and

5 WHEREAS, Seven Springs' recreational offerings have attracted
6 economic development in the adjoining townships and nearby
7 communities; and

8 WHEREAS, Seven Springs was founded near the best pristine
9 springs, the most majestic mountain scenery, solid farming and
10 timber terrain and developable ski hillsides; and

11 WHEREAS, Seven Springs was originally founded in 1932 by the
12 visionary German immigrant Adolph Dupre and his wife, Helen, who
13 were looking for beautiful mountain terrain to make their home;
14 and

15 WHEREAS, Today, Seven Springs is a vibrant asset of local,
16 regional, Statewide and national pride; therefore be it

17 RESOLVED, That the House of Representatives commemorate the
18 50th anniversary of the incorporation of the Borough of Seven
19 Springs in Somerset and Fayette Counties.
