## AN ACT

Amending the act of June 27, 2006 (1st Sp.Sess., P.L.1873, 1 No.1), entitled "An act providing for taxation by school districts, for the State funds formula, for tax relief in first class cities, for school district choice and voter participation, for other school district options and for a 5 task force on school cost reduction; making an appropriation; 6 prohibiting prior authorized taxation; providing for 7 installment payment of taxes; restricting the power of 8 certain school districts to levy, assess and collect taxes; 9 and making related repeals," in senior citizens property tax and rent rebate assistance, further providing for 10 11 definitions. 12 13 The General Assembly of the Commonwealth of Pennsylvania 14 hereby enacts as follows: Section 1. The definition of "income" in section 1303 of the 15 act of June 27, 2006 (1st Sp.Sess., P.L.1873, No.1), known as 16 the Taxpayer Relief Act, is amended to read: 17 18 Section 1303. - 1 "Income." All income from whatever source derived,
- 2 including, but not limited to:
- 3 (1) Salaries, wages, bonuses, commissions, income from
- 4 self-employment, alimony, support money, cash public
- 5 assistance and relief.
- 6 (2) The gross amount of any pensions or annuities,
- 7 including railroad retirement benefits for calendar years
- 8 prior to 1999 and 50% of railroad retirement benefits for
- 9 calendar years 1999 and thereafter.
- 10 (3) [All] Fifty percent of all benefits received under
- 11 the Social Security Act (49 Stat. 620, 42 U.S.C. § 301 et
- seq.), except Medicare benefits[, for calendar years prior to
- 13 1999, and 50% of all benefits received under the Social
- 14 Security Act, except Medicare benefits, for calendar years
- 15 1999 and thereafter] and except that portion of benefits
- deducted to cover Medicare Part B premiums.
- 17 (4) All benefits received under State unemployment
- insurance laws and veterans' disability payments.
- 19 (5) All interest received from the Federal or any state
- 20 government or any instrumentality or political subdivision

- 22 (6) Realized capital gains and rentals.

- 24 (8) The gross amount of loss of time insurance benefits,
