- Amending Title 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, further providing for the 1

- makeup, jurisdiction and venue of the Philadelphia Municipal 3

- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. The definition of "Traffic Court of Philadelphia"
- in section 102 of Title 42 of the Pennsylvania Consolidated
- Statutes is amended to read: 10
- 11 § 102. Definitions.
- 12 Subject to additional definitions contained in subsequent
- provisions of this title which are applicable to specific 13
- provisions of this title, the following words and phrases when 14
- 15 used in this title shall have, unless the context clearly
- 16 indicates otherwise, the meanings given to them in this section:
- 17
- 18 "Traffic Court of Philadelphia." The [traffic court existing
- 19 under section 6(c) of Article V of the Constitution of

- 1 Pennsylvania and Subchapter B of Chapter 13 (relating to Traffic
- 2 Court of Philadelphia) so long as a community court has not been
- 3 established or in the event one has been discontinued in the
- 4 City and County of Philadelphia.] <u>Traffic Division under section</u>
- 5 1121(c) (relating to Philadelphia Municipal Court).
- 6 * * *
- 7 Section 2. Section 1121 of Title 42 is amended to read:
- 8 § 1121. Philadelphia Municipal Court.
- 9 <u>(a) Organization.--</u>The Philadelphia Municipal Court shall <u>be</u>
- 10 organized as follows:
- 11 (1) The General Division shall consist of 25 judges and
- 12 <u>hearing examiners OFFICERS appointed by the President Judge</u> <--
- of the Philadelphia Municipal Court.
- 14 (2) The Traffic Division shall consist of five FOUR <--

- judges elected to the Traffic Court of Philadelphia prior to
- the effective date of this paragraph. If a vacancy in the
- 17 <u>Traffic Division occurs because a judge is convicted or</u>
- 18 removed from office, the vacancy shall not be filled. This
- 19 paragraph shall expire on the later of:
- 20 (i) the date of the ratification by the electorate
- of an amendment to the Constitution of Pennsylvania
- abolishing the Philadelphia Traffic Court; or

- 26 (1) A judge in the General Division must be an attorney

- 28 (2) The salary of a judge in the General Division shall
- be as set forth in section 2.1(e) and (i) of the act of
- 30 September 30, 1983 (P.L.160, No.39), known as the Public

2	(3) The General Division shall exercise full
3	jurisdiction of the municipal court under section 1123(a)
4	(relating to jurisdiction and venue).
5	(c) Traffic Division
6	(1) A judge in the Traffic Division must:
7	(i) be an attorney at law; or
8	(ii) complete a course of training and instruction
9	in the duties of the offices and pass an examination in
10	the course.
11	(2) The salary of a judge in the Traffic Division shall
12	be as set forth in section 2.1(f) and (i) of the Public
13	Official Compensation Law.
14	(3) The Traffic Division shall, at the direction of the
15	President Judge of the Philadelphia Municipal Court, exercise
16	jurisdiction under section 1123(a)(9).
17	(4) This subsection shall apply during the terms of all
18	judges of the Philadelphia Traffic Court:
19	(i) who have been elected prior to January 1, 2014;
20	<u>and</u>
21	(ii) whose term expires after December 31, 2017.
22	(5) A judge identified in paragraph (4) shall, until the
23	expiration of the term to which the judge has been elected,
24	serve as a judge in the Traffic Division.

- 14 Section 4. Section 1302(a) introductory paragraph of Title
- 15 42 is amended and the section is amended by adding a subsection
- 16 to read:
- 17 § 1302. Jurisdiction and venue.
- 18 (a) General rule. -- Except <u>as set forth in subsection (a.1)</u>
- 19 or as otherwise prescribed by any general rule adopted pursuant
- 20 to section 503 (relating to reassignment of matters), each
- 21 traffic court shall have jurisdiction of all prosecutions for
- 22 summary offenses arising under:
- 23 * * *
- 24 (a.1) Traffic Court of Philadelphia.--
- 25 (1) Except as otherwise prescribed by any general rule
- 26 <u>adopted pursuant to section 503 (relating to reassignment of</u>

- 13 <u>(a) Establishment.--</u>The Traffic Court of Philadelphia shall
- 14 be a court not of record [and shall consist of seven judges].
- 15 The court is established for the City and County of
- 16 Philadelphia.
- 17 (b) Composition. -- The court shall consist of two judges:
- 18 (1) who are serving on the court on the effective date
- of this subsection; and
- 20 (2) whose terms expire on December 31, 2017.
- 21 (c) Expiration. -- This section shall expire on the later of:
- 22 (1) the date of the ratification by the electorate of an
- amendment to the Constitution of Pennsylvania abolishing the
