1 2 3	Amending Title 12 (Commerce and Trade) of the Pennsylvania Consolidated Statutes, prohibiting the sale of shark fins; and imposing a penalty.
4	The General Assembly of the Commonwealth of Pennsylvania
5	hereby enacts as follows:
6	Section 1. Title 12 of the Pennsylvania Consolidated
7	Statutes is amended by adding a chapter to read:

15	<u>§ 5501. Definitions.</u>
16	The following words and phrases when used in this chapter
17	shall have the meanings given to them in this section unless the
18	context clearly indicates otherwise:

1	"Shark fin." The raw, dried or otherwise processed detached
2	fin or the raw, dried or otherwise processed detached tail of a
3	member of the superorder selachimorpha. The term does not
4	include a drug approved by the Food and Drug Administration of
5	the Department of Health and Human Services of the United
6	<u>States.</u>
7	<u>§ 5502. Prohibition.</u>
8	(a) ProhibitionExcept as provided in subsection (b), a
9	person may not possess, sell, offer for sale, trade or
10	<u>distribute a shark fin.</u>
11	(b) Exceptions
12	(1) Possession of a shark fin is permissible if:
13	(i) the shark was landed under a license from
14	another state; and
15	(ii) it is being possessed in this Commonwealth for
16	taxidermy.
17	(2) Before September 1, 2013, a restaurant may possess,
18	sell, offer for sale, trade or distribute shark fin that:
19	(i) is prepared for consumption; and
20	(ii) the restaurant possesses prior to September 2,
21	<u>2012.</u>
22	<u>§ 5503. Penalty.</u>
23	<u>A person who violates section 5502 (relating to prohibition)</u>
24	commits a misdemeanor of the third degree SUMMARY OFFENSE. Each <
25	shark fin possessed, sold, offered for sale or purchased in
26	violation of section 5502 is a separate offense.
27	Section 2. This act shall take effect in 60 days.
