AN ACT

- Establishing the Pennsylvania Community College Affordability
 Task Force within the Department of Education; and providing
 for its powers and duties and for administrative support.

 The General Assembly of the Commonwealth of Pennsylvania
 hereby enacts as follows:

 Section 1. Pennsylvania Community College Affordability Task

 Force.
- 8 (a) Establishment.--There is established within the
- 9 Department of Education a task force on the affordability of
- 10 community college education.
- 11 (b) Composition.--The task force shall be composed of the
- 12 following members:
- 13 (1) The Secretary of Education, who shall act as 14 chairperson of the task force.
- 15 (2) Six representatives of community colleges, including
- four college presidents and two members of boards of trustees
- of community colleges to be appointed by the Pennsylvania

- 2 (3) Two members of the Senate to be appointed by the 3 President pro tempore of the Senate.
 - (4) Two members of the House of Representatives to be appointed by the Speaker of the House of Representatives.
- 6 (5) One county commissioner that represents a county
 7 that sponsors a local community college as appointed by the
 8 Secretary of Education.
 - (6) One member of a school board that sponsors a local community college as appointed by the Secretary of Education.
- 11 (7) Two representatives to be appointed by the Governor 12 who are members of the business community.
- 13 (8) Two students attending community colleges as
 14 appointed by the Pennsylvania Commission for Community
 15 Colleges.
- 16 (9) TWO FACULTY MEMBERS EMPLOYED BY COMMUNITY COLLEGES <-17 AS APPOINTED BY THE PENNSYLVANIA COMMISSION FOR COMMUNITY
 18 COLLEGES.
- 19 (c) Study.--The task force shall examine and make
 20 recommendations regarding the viability and sustainability of
 21 the current community college funding model, accessibility of
- 22 community college services across this Commonwealth, and the
- 23 long-term affordability and accessibility of a community college
- 24 education for residents of this Commonwealth. The task force
- 25 should also consider the various components of the community
- 26 college mission, including open access and workforce
- 27 development.
- 28 (d) Report to the General Assembly. -- The task force shall
- 29 issue a report of its findings and recommendations to the
- 30 Governor, the President pro tempore of the Senate, the Speaker

- 1 of the House of Representatives, the Minority Leader of the
- 2 Senate, the Minority Leader of the House of Representatives, the
- 3 chair and minority chair of the Education Committee of the
- 4 Senate and the chair and minority chair of the Education
- 5 Committee of the House of Representatives. This report shall be
- 6 submitted within 180 days after the first meeting of the task
- 7 force.
- 8 (e) Meetings. -- The task force shall meet as deemed necessary
- 9 by the chair in order to carry out the study and make
- 10 recommendations.
- 11 (f) Compensation. -- Task force members shall receive no
- 12 compensation for their services but shall be reimbursed for all
- 13 necessary travel and other reasonable expenses incurred in
- 14 connection with the performance of their duties as members.
- 15 (g) Duties of department. -- The Department of Education shall
- 16 provide administrative support, office space and any other
- 17 technical assistance required by the task force to carry out its
- 18 duties under this section.
- 19 Section 2. Effective date.
- This act shall take effect immediately.
