AN ACT

- 1 Amending Title 51 (Military Affairs) of the Pennsylvania
- Consolidated Statutes, further providing for tuition waiver
- for children and spouses of deceased soldiers.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 3503(a) and (a.1) of Title 51 of the
- 7 Pennsylvania Consolidated Statutes are amended to read:
- 8 § 3503. Tuition waiver for children and spouses of deceased
- 9 soldiers.
- 10 (a) Children.--The children of members of the Pennsylvania
- 11 National Guard who were killed or die as a result of injuries
- 12 received while performing duty in an official duty status
- 13 authorized under Federal or State law shall be entitled to a
- 14 waiver of all tuition costs and fees remaining after receipt of
- 15 other scholarships and education benefits and Federal and State
- 16 grants, including, but not limited to, educational gratuities

- 1 for which the children are or may be eligible under the act of
- 2 December 16, 1998 (P.L.980, No.129), known as the Police
- 3 Officer, Firefighter, Correction Employee and National Guard
- 4 Member Child Beneficiary Education Act, at all Pennsylvania
- 5 State-owned colleges or universities, approved trade schools,
- 6 State-related institutions of higher learning or community
- 7 colleges in this Commonwealth for a period not exceeding eight
- 8 semesters or four years, whichever is greater. In order to be
- 9 eligible for waiver of tuition and fees under this section, the
- 10 member of the Pennsylvania National Guard must have been a bona
- 11 fide resident of Pennsylvania at any time during his service in
- 12 the Pennsylvania National Guard or at the time of his death, and
- 13 the member's children must be bona fide residents of
- 14 Pennsylvania, eligible for resident tuition at the institution
- 15 to which they have applied, at the time they apply for the
- 16 tuition and fee waiver.
- 17 (a.1) Spouses.--The spouse of a member of the Pennsylvania
- 18 National Guard who was killed or dies as a result of injuries
- 19 received while performing duty in an official duty status
- 20 authorized under Federal or State law shall be entitled to a
- 21 waiver of all tuition costs and fees remaining after receipt of
- 22 other scholarships and education benefits and Federal and State
- 23 grants at any Pennsylvania State-owned college or university,
- 24 approved trade school, State-related institution of higher
- 25 learning or community college in this Commonwealth for a period
- 26 not exceeding eight semesters or four years, whichever is
- 27 greater. A spouse shall be eligible for a waiver of all tuition
- 28 costs and fees remaining after receipt of other scholarships and
- 29 education benefits and Federal and State grants under this
- 30 subsection for a period not to exceed ten years from the date

- 1 the member is killed or dies as a result of injuries while in
- 2 Federal or State active duty or until the spouse remarries,
- 3 whichever occurs first. In order to be eligible for waiver of
- 4 tuition and fees under this section, the member of the
- 5 Pennsylvania National Guard must have been a bona fide resident
- 6 of Pennsylvania <u>at any time during his service in the</u>
- 7 Pennsylvania National Guard or at the time of his death, and the
- 8 member's spouse must be a bona fide resident of Pennsylvania,
- 9 eligible for resident tuition at the institution to which the
- 10 spouse has applied, at the time the spouse applies for the
- 11 tuition and fee waiver.

- 13 Section 2. The amendment of 51 Pa.C.S. § 3503(a) and (a.1)
- 14 shall be retroactive to September 11, 2001.
- 15 Section 3. This act shall take effect immediately.
