AN ACT

Amending the act of March 24, 1905 (P.L.50, No.35), entitled, "An act to reorganize the Board of Trustees of The 2 Pennsylvania State College," further providing for title of 3 the act and for members of the Board of Trustees of The 4 Pennsylvania State University; and providing for quorum and 5 lifetime service limitation. 6 7 The General Assembly of the Commonwealth of Pennsylvania

- 8 hereby enacts as follows:
- 9 Section 1. The title of the act of March 24, 1905 (P.L.50,
- 10 No.35), entitled, "An act to reorganize the Board of Trustees of
- The Pennsylvania State College," is amended to read: 11
- 12 AN ACT
- 13 To reorganize the Board of Trustees of The Pennsylvania State
- 14 [College] University.
- 15 Section 2. Section 1 of the act, amended June 24, 1939
- 16 (P.L.863, No.367), is amended to read:
- 17 Section 1. Be it enacted, &c., That[, in addition to the
- 18 present elective members of the Board of Trustees of The
- 19 Pennsylvania State College, the said Board shall consist of the
- following members, to wit: Three members to be elected each 20

- 1 year, for a term of three years each, by the alumni of said
- 2 college; two members to be appointed each year, for a term of
- 3 three years each, by the Governor of the Commonwealth, and
- 4 confirmed by the Senate; and the following members to serve ex-
- 5 officio during their respective terms of office: The Governor of
- 6 the Commonwealth, the President of the College, the State
- 7 Superintendent of Public Instruction, the Secretary of
- 8 Agriculture, and the Secretary of Mines.]:
- 9 (1) The Board of Trustees of The Pennsylvania State
- 10 University, formerly The Pennsylvania State College, shall be
- 11 reorganized in the manner that is deemed appropriate by the
- 12 <u>current elective members and shall from this day forward consist</u>
- 13 of the following members:
- 14 (i) Six members that are representative of the interest of
- 15 the alumni to be elected, for a term of three years each, by the
- 16 <u>alumni of the university.</u>
- 17 <u>(ii) Four members that are representative of the interest of</u>
- 18 the agricultural community to be elected, for a term of three
- 19 years each, by the county agricultural societies.
- 20 (iii) Four members that are representative of the interest
- 21 of the business and industry community to be elected, for a term
- 22 of three years each. At least two of the businesses and
- 23 industry's representatives shall represent fields that are major
- 24 academic focuses of the university. The Board of Trustees shall
- 25 develop a process for the selection of the business and industry
- 26 representative members that is fair and transparent, that
- 27 <u>involves the business and industry community and that is not a</u>
- 28 selection process by a vote of the Board of Trustees itself.
- 29 <u>(iv) Four members that are appointed by the Governor of the</u>
- 30 Commonwealth and confirmed by the Senate. At least one of these

- 1 members must be a student enrolled in a program offered by the
- 2 <u>university whose term shall expire at the time the student</u>
- 3 ceases to be enrolled at the university. All other members
- 4 appointed under this subparagraph shall have a term of three
- 5 years.
- 6 (v) The following members shall serve during their
- 7 <u>respective terms of office: the Governor, as a nonvoting member</u>
- 8 ex-officio; and the following three members of the Board of
- 9 Trustees shall serve as voting members ex-officio: the Secretary
- 10 of Agriculture, the Secretary of Conservation and Natural
- 11 Resources, and the Secretary of Education.
- 12 (2) The President of the University may not be a member of
- 13 <u>the Board of Trustees.</u>
- 14 (3) The elections and appointment of the members of the
- 15 Board of Trustees under paragraph (1)(i), (ii), (iii) and (iv)
- 16 shall be cycled in a manner that assures staggered expirations
- 17 of terms.
- 18 (4) The Board of Trustees may appoint emeriti members
- 19 provided that any member on the Board of Trustees by virtue of
- 20 emeritus status shall be wholly honorary without voting rights.
- 21 Participation rights that are vested solely in the statutorily
- 22 established members shall not be extended to emeriti members.
- 23 Section 3. The act is amended by adding sections to read:
- 24 Section 2.1. A majority of the voting members of the Board
- 25 <u>of Trustees shall be a quorum required for taking any official</u>
- 26 action by the Board.
- 27 <u>Section 2.2. No member of the Board of Trustees may serve</u>
- 28 more than a total of nine years on the Board of Trustees during
- 29 the course of that member's lifetime. This section shall apply
- 30 to all members of the Board of Trustees, regardless of their

- 1 respective election and appointment dates, who serve on the
- 2 effective date of this section, provided that any such member
- 3 whose current term would violate this section may continue to
- 4 <u>serve for the duration of such current term only.</u>
- 5 Section 4. Section 3 of the act is amended to read:
- 6 Section 3. (a) The officers of the Board of Trustees shall
- 7 be [chosen] <u>elected</u> annually, to serve for a period of one year
- 8 each[;] and shall be a [President] chair, a [Vice-President]
- 9 <u>Vice-Chair</u>, a Secretary, <u>and</u> a Treasurer.[, and an Executive
- 10 Committee of not less than three nor more than seven members,
- 11 whose duty it shall be, under the direction and subject to the
- 12 approval of the Board of Trustees, to transact such necessary
- 13 business as may arise in the intervals between regular meetings
- 14 of the Board. No member of the Board shall receive compensation
- 15 for his services; but shall be paid necessary traveling and
- 16 hotel expenses actually incurred in the performance of duty as
- 17 such member. The Treasurer shall not be a member of the board,
- 18 and shall give such bonds for the faithful performance of his
- 19 duties, and receive such compensation as the Board may, from
- 20 time to time, direct.]
- 21 (b) The Treasurer shall not be a member of the Board of
- 22 <u>Trustees</u>, and shall give such bonds for the faithful performance
- 23 of his duties, and receive such compensation as the Board of
- 24 Trustees may, from time to time, direct.
- 25 (c) An Executive Committee of not less than three nor more
- 26 than seven members, whose duty it shall be, under the direction
- 27 and subject to the approval of the Board of Trustee, to transact
- 28 such necessary business as may arise in the intervals between
- 29 regular meetings of the Board of Trustees.
- 30 (d) The President of the University shall not serve as an

- 1 officer of the Board of Trustees and shall not serve on the
- 2 Executive Committee, any standing committee, special committee
- 3 or subcommittee of the Board of Trustees.
- 4 (e) No member of the Board of Trustees shall receive
- 5 compensation for his services; but shall be paid necessary
- 6 traveling and hotel expenses actually incurred in the
- 7 performance of duty as such member.
- 8 Section 5. The act of February 22, 1855 (P.L.46, No.50),
- 9 entitled "An act to incorporate the Farmers' High School of
- 10 Pennsylvania," and any other act is repealed insofar as it is
- 11 inconsistent with this act.
- 12 Section 6. This act shall take effect immediately.
