AN ACT

Amending the act of April 9, 1929 (P.L.343, No.176), entitled, as amended, "An act relating to the finances of the State government; providing for the settlement, assessment, 3 collection, and lien of taxes, bonus, and all other accounts due the Commonwealth, the collection and recovery of fees and other money or property due or belonging to the Commonwealth, or any agency thereof, including escheated property and the 7 proceeds of its sale, the custody and disbursement or other 8 disposition of funds and securities belonging to or in the 9 10 possession of the Commonwealth, and the settlement of claims against the Commonwealth, the resettlement of accounts and 11 appeals to the courts, refunds of moneys erroneously paid to the Commonwealth, auditing the accounts of the Commonwealth 12 13 and all agencies thereof, of all public officers collecting 14 15 moneys payable to the Commonwealth, or any agency thereof, and all receipts of appropriations from the Commonwealth, 16 authorizing the Commonwealth to issue tax anticipation notes 17 to defray current expenses, implementing the provisions of 18 19 section 7(a) of Article VIII of the Constitution of Pennsylvania authorizing and restricting the incurring of 20 certain debt and imposing penalties; affecting every 21 department, board, commission, and officer of the State 22 government, every political subdivision of the State, and 23 certain officers of such subdivisions, every person, 24 association, and corporation required to pay, assess, or 25 26 collect taxes, or to make returns or reports under the laws imposing taxes for State purposes, or to pay license fees or 27 28 other moneys to the Commonwealth, or any agency thereof, 29 every State depository and every debtor or creditor of the

Commonwealth," in Local Government Capital Project Loan Fund <-provisions, further providing for assistance to-2 municipalities IN PRELIMINARY PROVISIONS, FURTHER PROVIDING 3 FOR METHOD OF PAYMENT AND METHOD OF FILING; IN DEPARTMENT OF 4 REVENUE, FURTHER PROVIDING FOR TRANSMISSION OF MONEY; IN 5 AGENTS FOR COLLECTION, FURTHER PROVIDING FOR CORPORATE 7 TREASURERS; IN BONUS AND TAX RECORDS, FURTHER PROVIDING FOR CORPORATE LOANS AND TAX, FOR MUNICIPAL LOANS AND TAX AND FOR 8 MONTHLY STATEMENTS BY REGISTERS OF WILLS; IN COLLECTIONS 9 OTHER THAN BY SETTLEMENT, FURTHER PROVIDING FOR DRIVER'S 10 LICENSE FEES AND FOR AMOUNTS PAYABLE TO STATE INSTITUTIONS; 11 IN PROCEDURE FOR DISBURSEMENT OF MONEY FROM STATE TREASURY, 12 PROVIDING FOR REIMBURSEMENT FOR ADMINISTRATIVE COSTS; IN 13 14 LOCAL GOVERNMENT CAPITAL PROJECT LOAN FUND, FURTHER PROVIDING FOR ASSISTANCE TO MUNICIPALITIES; IN SPECIAL FUNDS, FURTHER 15 PROVIDING FOR FUNDING AND FOR TRANSFER AND PROVIDING FOR 16 OTHER GRANTS; PROVIDING FOR ADDITIONAL SPECIAL FUNDS; IN 17 GENERAL BUDGET IMPLEMENTATION, PROVIDING FOR THE MOTOR 18 LICENSE FUND; IN 2012-2013 BUDGET IMPLEMENTATION, FURTHER 19 PROVIDING FOR THE DEPARTMENT OF PUBLIC WELFARE; IN 2012-2013 20 RESTRICTIONS ON APPROPRIATIONS, FURTHER PROVIDING FOR 21 VETERANS' TRUST FUND; PROVIDING FOR 2013-2014 BUDGET 22 IMPLEMENTATION; PROVIDING FOR 2013-2014 RESTRICTIONS ON 23 APPROPRIATIONS FOR FUNDS AND ACCOUNTS; IN AUDITS, FURTHER 24 25 PROVIDING FOR RACE HORSE DEVELOPMENT FUNDS; MAKING AN APPROPRIATION; AND MAKING RELATED REPEALS. 27 The General Assembly of the Commonwealth of Pennsylvania 28 hereby enacts as follows: 29 Section 1. Section 1603 D of the act of April 9, 1929 (P.L.343, No.176), known as The Fiscal Code, amended or added October 6, 1997 (P.L.387, No.46) and July 5, 2006 (P.L.296, 32 No.66), is amended to read: 33 SECTION 1. THE GENERAL ASSEMBLY FINDS AND DECLARES AS 34 FOLLOWS: THE INTENT OF THIS ACT IS TO PROVIDE FOR THE 35 IMPLEMENTATION OF THE 2013-2014 COMMONWEALTH BUDGET. 36 37 THE CONSTITUTION OF PENNSYLVANIA CONFERS NUMEROUS (2) 38 EXPRESS DUTIES UPON THE GENERAL ASSEMBLY, INCLUDING THE 39 PASSAGE OF A BALANCED BUDGET FOR THE COMMONWEALTH. (3) ARTICLE III, SECTION 24, OF THE CONSTITUTION OF 40 41 PENNSYLVANIA REQUIRES THE GENERAL ASSEMBLY TO ADOPT ALL 42 APPROPRIATIONS FOR THE OPERATION OF GOVERNMENT IN THE 43 COMMONWEALTH, REGARDLESS OF THEIR SOURCE. THE SUPREME COURT

- 1 HAS REPEATEDLY AFFIRMED THAT, "IT IS FUNDAMENTAL WITHIN
- 2 PENNSYLVANIA'S TRIPARTITE SYSTEM THAT THE GENERAL ASSEMBLY
- 3 ENACTS THE LEGISLATION ESTABLISHING THOSE PROGRAMS WHICH THE
- 4 STATE PROVIDES FOR ITS CITIZENS AND APPROPRIATES THE FUNDS
- 5 NECESSARY FOR THEIR OPERATION."
- 6 (4) PURSUANT TO ARTICLE VIII, SECTION 13 OF THE
- 7 CONSTITUTION OF PENNSYLVANIA, THE GENERAL ASSEMBLY IS
- 8 EXPLICITLY REQUIRED TO ADOPT A BALANCED COMMONWEALTH BUDGET.
- 9 GIVEN THE UNPREDICTABILITY AND POTENTIAL INSUFFICIENCY OF
- 10 REVENUE COLLECTIONS, VARIOUS CHANGES IN STATE LAW RELATING TO
- 11 SOURCES OF REVENUE, THE COLLECTION OF REVENUE AND THE
- 12 IMPLEMENTATION OF STATUTES WHICH IMPACT REVENUE MAY BE
- 13 REQUIRED TO DISCHARGE THIS CONSTITUTIONAL OBLIGATION.
- 14 (5) ARTICLE III, SECTION 11, OF THE CONSTITUTION OF
- 15 PENNSYLVANIA REQUIRES THE ADOPTION OF A GENERAL APPROPRIATION
- 16 BILL THAT EMBRACES "NOTHING BUT APPROPRIATIONS." WHILE
- 17 ACTUAL APPROPRIATIONS CAN BE CONTAINED IN A GENERAL
- 18 APPROPRIATIONS ACT, THE ACHIEVEMENT AND IMPLEMENTATION OF A
- 19 COMPREHENSIVE BUDGET INVOLVES MORE THAN APPROPRIATIONS.
- 20 ULTIMATELY, THE BUDGET HAS TO BE BALANCED UNDER ARTICLE VIII,
- 21 SECTION 13, OF THE CONSTITUTION OF PENNSYLVANIA. THIS MAY
- 22 NECESSITATE CHANGES TO SOURCES OF FUNDING AND ENACTMENT OF
- 23 STATUTES TO ACHIEVE FULL COMPLIANCE WITH THESE CONSTITUTIONAL
- 24 PROVISIONS.
- 25 (6) FOR THE REASONS SET FORTH IN PARAGRAPHS (1), (2),
- 26 (3), (4) AND (5), IT IS THE INTENT OF THE GENERAL ASSEMBLY
- 27 THROUGH THIS ACT TO PROVIDE FOR THE IMPLEMENTATION OF THE
- 28 2013-2014 COMMONWEALTH BUDGET.
- 29 (7) EVERY PROVISION OF THIS ACT RELATES TO THE
- 30 IMPLEMENTATION OF THE OPERATING BUDGET OF THE COMMONWEALTH

- 1 FOR THIS FISCAL YEAR, ADDRESSING IN VARIOUS WAYS THE FISCAL
- 2 OPERATIONS, REVENUES AND POTENTIAL LIABILITIES OF THE
- 3 COMMONWEALTH. TO THAT END, THIS ACT PLACES CONDITIONS ON
- 4 APPROPRIATIONS, PROVIDES FOR ACCOUNTABILITY FOR SPENDING AND
- 5 MAKES ANY NECESSARY TRANSFERS OR OTHER CHANGES NECESSARY TO
- 6 IMPACT THE AVAILABILITY OF REVENUE OR THE FISCAL CONDITIONS
- 7 OF THE COMMONWEALTH, IN ORDER TO MEET THE REQUIREMENTS OF
- 8 ARTICLE VIII, SECTION 13, OF THE CONSTITUTION OF PENNSYLVANIA
- 9 AND TO IMPLEMENT THE ACT OF , 2013 (P.L. , NO. A), KNOWN AS
- 10 THE GENERAL APPROPRIATION ACT OF 2013.
- 11 SECTION 2. SECTION 9 OF THE ACT OF APRIL 9, 1929 (P.L.343,
- 12 NO.176), KNOWN AS THE FISCAL CODE, AMENDED JULY 2, 2012
- 13 (P.L.823, NO.87), IS AMENDED TO READ:
- 14 SECTION 9. METHOD OF PAYMENT. -- (A) NOTWITHSTANDING ANY
- 15 OTHER PROVISIONS OF THIS ACT OR ANY OTHER ACTS, THE STATE
- 16 TREASURER AND THE SECRETARY OF REVENUE SHALL JOINTLY PRESCRIBE
- 17 BY REGULATION THE METHOD OF PAYMENT OF OBLIGATIONS DUE THE
- 18 COMMONWEALTH. SUCH REGULATIONS SHALL INCLUDE:
- 19 (1) REQUIRING PAYMENT BY ELECTRONIC FUNDS TRANSFERS (EFT)
- 20 WHICH INCLUDES AUTOMATED CLEARINGHOUSE DEBIT, AUTOMATED
- 21 CLEARINGHOUSE CREDIT, WIRE TRANSFER AND ANY OTHER MEANS THAT MAY
- 22 BE AVAILABLE TO OBTAIN FUNDS DUE THE COMMONWEALTH IN THE MOST
- 23 EXPEDITIOUS MANNER. THE PAYOR SHALL SELECT WHICH METHOD OF
- 24 ELECTRONIC FUNDS TRANSFER HE WISHES TO UTILIZE FROM AMONG THESE
- 25 OPTIONS.
- 26 (2) SETTING THE DATE ON WHICH A PAYMENT IS DEEMED TO HAVE
- 27 BEEN RECEIVED WHEN A METHOD OTHER THAN MAIL IS REQUIRED.
- 28 (3) ESTABLISHING PROCEDURES TO BE FOLLOWED WHEN A METHOD
- 29 OTHER THAN MAIL IS REQUIRED.
- 30 (4) ANY OTHER PROVISIONS NECESSARY TO ENSURE THE PROMPT

- 1 DEPOSIT OF FUNDS LEGALLY DUE THE COMMONWEALTH.
- 2 (5) AN OPTION PERMITTING PAYMENT BY CERTIFIED OR CASHIER'S
- 3 CHECK DELIVERED IN PERSON OR BY COURIER TO THE DEPARTMENT OF
- 4 REVENUE ON OR BEFORE THE DUE DATE OF THE OBLIGATION, IN LIEU OF
- 5 PAYMENT BY ELECTRONIC FUNDS TRANSFER.
- 6 (B) THE REGULATIONS SHALL NOT REQUIRE:
- 7 (1) ANY PAYMENT TO BE POSTED TO A COMMONWEALTH ACCOUNT PRIOR
- 8 TO THE DUE DATE, INCLUDING GRACE PERIODS, ESTABLISHED BY LAW OR
- 9 REGULATIONS.
- 10 (2) CHANGES TO THE METHOD OF PAYMENT FOR THOSE PAYMENTS MADE
- 11 BY INDIVIDUALS UNDER ARTICLE III OF THE ACT OF MARCH 4, 1971
- 12 (P.L.6, NO.2), KNOWN AS THE "TAX REFORM CODE OF 1971."
- 13 (3) CHANGES TO THE METHOD OF PAYMENT WHEN THE PAYMENT IS
- 14 LESS THAN [TEN THOUSAND DOLLARS (\$10,000)] ONE THOUSAND DOLLARS
- 15 (\$1,000).
- 16 (4) AUTOMATED CLEARINGHOUSE DEBIT AS THE SOLE AND EXCLUSIVE
- 17 MEANS OF COMPLYING WITH THIS ACT AND THE REGULATIONS PROMULGATED
- 18 PURSUANT TO THIS ACT.
- 19 SECTION 3. SECTION 10 OF THE ACT, ADDED OCTOBER 9, 2009
- 20 (P.L.537, NO.50), IS AMENDED TO READ:
- 21 SECTION 10. METHOD OF FILING.--(A) THE DEPARTMENT OF
- 22 REVENUE MAY REQUIRE ANY RETURN, REPORT OR OTHER DOCUMENT
- 23 REQUIRED TO BE FILED FOR A TAX ADMINISTERED BY THE DEPARTMENT
- 24 PREPARED BY A THIRD PARTY WHO SUBMITS [FIFTY OR] MORE THAN TEN
- 25 RETURNS, REPORTS OR OTHER DOCUMENTS REQUIRED TO BE FILED PER
- 26 YEAR TO BE FILED BY ANY METHOD PRESCRIBED BY THE DEPARTMENT,
- 27 INCLUDING BY TELEPHONIC, ELECTRONIC OR OTHER METHOD. NOTICE OF
- 28 THE METHOD OF FILING SHALL BE PUBLISHED IN THE PENNSYLVANIA
- 29 BULLETIN AND ON THE DEPARTMENT OF REVENUE'S INTERNET WEBSITE AT
- 30 LEAST SIXTY DAYS PRIOR TO THE DUE DATE OF THE RETURN, REPORT OR

- 1 OTHER DOCUMENT REQUIRED TO BE FILED BY TELEPHONIC, ELECTRONIC OR
- 2 OTHER METHOD. THE NOTICE SHALL REFER TO THIS SECTION.
- 3 (B) FAILURE TO FILE A RETURN, REPORT OR OTHER DOCUMENT BY
- 4 THE METHOD REQUIRED UNDER SUBSECTION (A) SHALL SUBJECT THE TAX
- 5 PREPARER TO A PENALTY OF ONE PERCENT OF THE TAX DUE ON THE
- 6 RETURN, REPORT OR OTHER DOCUMENT UP TO A MAXIMUM OF FIVE HUNDRED
- 7 DOLLARS (\$500), BUT NOT LESS THAN TEN DOLLARS (\$10). THIS
- 8 PENALTY SHALL BE ASSESSED AND COLLECTED IN THE MANNER PROVIDED
- 9 BY THE ACT OF MARCH 4, 1971 (P.L.6, NO.2), KNOWN AS THE "TAX
- 10 REFORM CODE OF 1971." THIS PENALTY SHALL BE IN ADDITION TO ANY
- 11 CIVIL PENALTY IMPOSED IN THE APPLICABLE ARTICLE OF THE "TAX
- 12 REFORM CODE OF 1971" FOR FAILURE TO FILE A RETURN, REPORT OR
- 13 OTHER DOCUMENT. THE CRIMINAL PENALTY FOR FAILURE TO FILE A
- 14 RETURN, REPORT OR OTHER DOCUMENT BY THE METHOD REQUIRED UNDER
- 15 SUBSECTION (A) SHALL BE THE SAME AS THE CRIMINAL PENALTY FOR
- 16 FAILURE TO FILE A RETURN, REPORT OR OTHER DOCUMENT UNDER THE
- 17 APPLICABLE ARTICLE OF THE "TAX REFORM CODE OF 1971."
- 18 (C) (1) THE DEPARTMENT OF REVENUE MAY WAIVE THE REQUIREMENT
- 19 TO FILE BY THE METHOD REQUIRED UNDER SUBSECTION (A) WHEN THE
- 20 DEPARTMENT DETERMINES THAT ANY OF THE FOLLOWING APPLY:
- 21 (I) THE PRESCRIBED FILING METHOD CAUSES AN UNDUE HARDSHIP.
- 22 (II) THE PREPARER OR TAXPAYER REQUESTS A WAIVER IN WRITING
- 23 THAT CLEARLY STATES WHY THE FILING METHOD CAUSES AN UNDUE
- 24 HARDSHIP.
- 25 (2) IN DETERMINING WHETHER FILING BY THE METHOD REQUIRED
- 26 UNDER SUBSECTION (A) CAUSES AN UNDUE HARDSHIP, THE DEPARTMENT OF
- 27 REVENUE MAY CONSIDER UNUSUAL CIRCUMSTANCES THAT MAY PREVENT THE
- 28 PERSON FROM FILING BY THE PRESCRIBED METHOD OR ANY OTHER FACTOR
- 29 THAT THE DEPARTMENT DETERMINES IS RELEVANT.
- 30 SECTION 4. SECTION 209 OF THE ACT, AMENDED JULY 2, 2012

- 1 (P.L.823, NO.87), IS AMENDED TO READ:
- 2 SECTION 209. TRANSMISSION OF MONEYS. -- (A) EXCEPT AS
- 3 PROVIDED IN SUBSECTION (B), ALL MONEYS RECEIVED BY THE
- 4 DEPARTMENT OF REVENUE DURING ANY DAY SHALL BE TRANSMITTED
- 5 PROMPTLY TO THE TREASURY DEPARTMENT, AND THE TREASURY DEPARTMENT
- 6 SHALL FORTHWITH ISSUE ITS RECEIPT TO THE DEPARTMENT OF REVENUE
- 7 FOR SUCH MONEYS, AND CREDIT THEM TO THE FUND AND ACCOUNT
- 8 DESIGNATED BY THE DEPARTMENT OF REVENUE.
- 9 DETAILED STATEMENTS OF ALL MONEYS RECEIVED SHALL BE FURNISHED
- 10 TO THE TREASURY DEPARTMENT AND THE DEPARTMENT OF THE AUDITOR
- 11 GENERAL CONTEMPORANEOUSLY WITH THE TRANSMISSION OF SUCH MONEYS
- 12 TO THE TREASURY DEPARTMENT.
- 13 (B) THE FOLLOWING APPLY TO CONTRACTS:
- 14 (1) [THE] EXCEPT AS SET FORTH IN PARAGRAPH (1.1), THE
- 15 DEPARTMENT OF REVENUE MAY ENTER INTO CONTRACTS ALLOWING THE
- 16 CONTRACTOR TO BE PAID FOR PRODUCTS PROVIDED OR SERVICES
- 17 RENDERED, ON A CONTINGENT FEE BASIS, FOR TAXES, INTEREST,
- 18 PENALTY OR FEES COLLECTED OR REFUNDS SAVED.
- 19 (1.1) THE DEPARTMENT OF REVENUE MAY NOT ENTER INTO A
- 20 CONTINGENT FEE CONTRACT UNDER WHICH THE CONTRACTOR DIRECTLY
- 21 CONDUCTS A FIELD AUDIT.
- 22 (2) THE MONEY COLLECTED UNDER PARAGRAPH (1) SHALL BE
- 23 DEPOSITED INTO A RESTRICTED RECEIPT ACCOUNT, OUT OF WHICH THE
- 24 CONTINGENT FEES SHALL BE PAID. BY THE LAST DAY OF EACH MONTH,
- 25 ALL MONEY REMAINING IN THE RESTRICTED RECEIPT ACCOUNT SHALL BE
- 26 TRANSFERRED TO THE GENERAL FUND.
- 27 (3) THE DEPARTMENT OF REVENUE SHALL SUBMIT AN ANNUAL REPORT
- 28 SETTING FORTH THE NUMBER OF CONTRACTS ENTERED INTO UNDER
- 29 PARAGRAPH (1), THE AMOUNT COLLECTED AND THE PERCENTAGE OF THE
- 30 CONTINGENCY.

- 1 SECTION 5. SECTION 606 OF THE ACT IS REPEALED:
- 2 [SECTION 606. TREASURERS OF PRIVATE CORPORATIONS TO COLLECT
- 3 TAX FROM INTEREST PAID. -- THE TREASURER OF EVERY PRIVATE
- 4 CORPORATION, EXCEPT CORPORATIONS OF THE FIRST CLASS AND
- 5 COOPERATIVE AGRICULTURAL ASSOCIATIONS NOT HAVING CAPITAL STOCK
- 6 AND NOT CONDUCTED FOR PROFIT, SHALL CONTINUE TO BE THE AGENT OF
- 7 THE COMMONWEALTH, FOR THE PURPOSE OF ASSESSING, COLLECTING, AND
- 8 PAYING INTO THE STATE TREASURY THE TAX IMPOSED BY LAW UPON ANY
- 9 SCRIP, BOND, CERTIFICATE, OR EVIDENCE OF INDEBTEDNESS, ISSUED OR
- 10 ASSUMED BY SUCH CORPORATION, OR UPON WHICH INTEREST SHALL BE
- 11 PAID AND HELD BY RESIDENTS OF THIS COMMONWEALTH, INCLUDING
- 12 INTEREST PAID FOR PRIOR YEARS, BUT ALL TAXES THUS COLLECTED
- 13 SHALL BE PAID INTO THE STATE TREASURY, THROUGH THE DEPARTMENT OF
- 14 REVENUE.
- 15 FOR HIS SERVICES AS SUCH AGENT, EVERY SUCH TREASURER SHALL BE
- 16 COMPENSATED AT THE RATES NOW PROVIDED BY LAW.]
- 17 SECTION 6. SECTION 708 OF THE ACT, AMENDED JULY 13, 1957
- 18 (P.L.838, NO.388), IS REPEALED:
- 19 [SECTION 708. REPORT OF CORPORATE LOANS AND PAYMENT OF
- 20 TAX.--THE TREASURER OF EVERY PRIVATE CORPORATION, EXCEPT
- 21 CORPORATIONS OF THE FIRST CLASS, AND COOPERATIVE AGRICULTURAL
- 22 ASSOCIATIONS NOT HAVING CAPITAL STOCK AND NOT CONDUCTED FOR
- 23 PROFIT, SHALL REPORT, ANNUALLY, ON OR BEFORE THE FIFTEENTH DAY
- 24 OF APRIL, TO THE DEPARTMENT OF REVENUE, THE AMOUNT OF
- 25 INDEBTEDNESS OF THE CORPORATION, OR ASSUMED BY IT, OR UPON WHICH
- 26 IT PAYS INTEREST, OWNED BY RESIDENTS OF THIS COMMONWEALTH, AS
- 27 NEARLY AS THE SAME CAN BE ASCERTAINED, AND WHENEVER ANY SUCH
- 28 CORPORATION SHALL MAKE A PAYMENT OF INTEREST ON ANY SCRIP,
- 29 BONDS, CERTIFICATES AND EVIDENCE OF INDEBTEDNESS, DUE AND
- 30 PAYABLE FOR PRIOR YEARS, IT SHALL ALSO BE THE DUTY OF THE

- 1 TREASURER OF SUCH CORPORATION TO REPORT THE SAME FORTHWITH TO
- 2 THE DEPARTMENT OF REVENUE, GIVING SUCH INFORMATION ABOUT SUCH
- 3 PAYMENT AS THE DEPARTMENT OF REVENUE SHALL REQUIRE. EVERY SUCH
- 4 TREASURER, AT THE TIME OF MAKING EVERY REPORT REQUIRED BY THIS
- 5 SECTION, SHALL COMPUTE AND PAY TO THE DEPARTMENT THE TAX DUE THE
- 6 COMMONWEALTH UPON SUCH SCRIP, BONDS, CERTIFICATES AND EVIDENCES
- 7 OF INDEBTEDNESS, AS REQUIRED BY LAW.]
