Consideration of criminal conviction. 9 10 11 (b.1) Parent convicted of certain offenses. -- No court shall 12 award custody, partial custody or supervised physical custody to a parent who has been convicted of any of the following offenses 13 14 against the other parent of the child who is the subject of the 15 order and who was conceived as a result of: 16 (1) Rape under 18 Pa.C.S. § 3121. 17 (2) Statutory sexual assault under 18 Pa.C.S. § 3122.1. (3) Sexual assault under 18 Pa.C.S. § 3124.1. 18 19 (4) Institutional sexual assault under 18 Pa.C.S. §
