AN ACT

1 Amending Title 34 (Game) of the Pennsylvania Consolidated
2 Statutes, further providing for license costs and fees.

3 The General Assembly of the Commonwealth of Pennsylvania
4 hereby enacts as follows:

5 Section 1. Section 2709(a) of Title 34 of the Pennsylvania
6 Consolidated Statutes is amended to read:

7 § 2709. License costs and fees.

8 (a) License costs.--Any person who qualifies under the
9 provisions of this chapter shall be issued the applicable
10 license upon payment of the following costs and the issuing
11 agent's fee:

12 (1) (i) Junior resident hunting - \$5.

13 (ii) Junior resident combination hunting and
14 furtaker - \$8.

15 (2) (i) Adult resident hunting - \$19 for the period
16 ending before July 1, 2014.

17 (ii) Adult resident hunting - \$25 for the period
18 beginning after June 30, 2014, and ending before July 1,

1 2017.

2 (iii) Adult resident hunting - \$30 for the period
3 beginning after June 30, 2017, and ending before July 1,
4 2020.

5 (iv) Adult resident hunting - \$35 for the period
6 beginning after June 30, 2020, and thereafter.

7 [(ii)] (v) Resident military personnel hunting - \$1.

8 [(iii)] (vi) Former prisoner of war hunting - \$1.

9 [(iv)] (vii) Pennsylvania National Guard hunting -
10 \$1.

11 [(v)] (viii) Reserve component of the armed forces
12 hunting - \$1.

13 (3) (i) Senior resident hunting - \$12.

14 (ii) Senior lifetime resident hunting - \$50.

15 (iii) Senior lifetime resident combination hunting
16 and furtaker - \$100.

17 (4) Bear hunting:

18 (i) Resident - \$15.

19 (ii) Nonresident - \$35.

20 (5) Antlerless deer:

21 (i) Resident, including resident military, resident
22 disabled veteran and landowner - \$5 for the period ending
23 before July 1, 2014.

24 (ii) Resident, including resident military, resident
25 disabled veteran and landowner - \$12 for the period
26 beginning after June 30, 2014, and ending before July 1,
27 2020.

28 (iii) Resident, including resident military,
29 resident disabled veteran and landowner - \$15 for the
30 period beginning after June 30, 2020, and thereafter.

(21) Elk hunting license:

(i) Resident - \$25.

(ii) Nonresident - \$250.

(22) Special wild turkey license:

(i) Resident - \$20.

(ii) Nonresident - \$40.

(23) (i) Adult resident combination hunting, furtaker, archery and muzzleloader license - \$67 for the period beginning after June 30, 2014, and ending before July 1, 2018.

(ii) Adult resident combination hunting, furtaker, archery and muzzleloader license - \$72 for the period beginning after June 30, 2017, and ending before July 1, 2020.

(iii) Adult resident combination hunting, furtaker, archery and muzzleloader license - \$77 for the period beginning after June 30, 2020, and thereafter.
