AN ACT

- 1 Providing for paid family and medical leave for eligible
- employees under certain circumstances and for regulations by
- the Department of Labor and Industry.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Short title.
- 7 This act shall be known and may be cited as the Paid Family
- 8 Leave Act.
- 9 Section 2. Definitions.
- 10 The following words and phrases when used in this act shall
- 11 have the meanings given to them in this section unless the
- 12 context clearly indicates otherwise:
- 13 "Department." The Department of Labor and Industry of the
- 14 Commonwealth.
- "Eligible employee." As defined in the Family and Medical
- 16 Leave Act of 1993 (Public Law 103-3, 29 U.S.C. § 2601 et seq.),
- 17 an employee who is the parent through birth, adoption or
- 18 placement through foster care of a new child.
- 19 "Employer." Any person engaged in commerce or in any

- 1 industry or activity affecting commerce who employs at least
- 2 four employees in this Commonwealth for each working day during
- 3 each of 20 or more calendar workweeks in the current or
- 4 preceding calendar year. The term includes:
- 5 (1) Any person who acts, directly or indirectly, in the
- 6 interest of an employer to any of the employees of such
- 7 employer and any successor in interest of such employer.
- 8 (2) The Commonwealth and any of its political
- 9 subdivisions and municipal authorities.
- 10 "FMLA." The Family and Medical Leave Act of 1993 (Public Law
- 11 103-3, 29 U.S.C. § 2601 et seq.).
- 12 Section 3. Eligibility.
- 13 (a) General rule. -- An employer subject to this section shall
- 14 provide not less than 12 weeks of paid leave to an eligible
- 15 employee to care for the child during the period extending from
- 16 the beginning of a pregnancy to one year after the birth,
- 17 adoption or placement of the child.
- 18 (b) Protections. -- An eligible employee who takes leave
- 19 provided under subsection (a) is entitled to the same
- 20 protections and rights that an eligible employee is entitled to
- 21 under the FMLA, including protection from discrimination and
- 22 interference, the right to reinstatement and the right to
- 23 continuation of health care benefits.
- 24 (c) Amount of leave and benefits.--
- 25 (1) The amount of leave taken by an eligible employee
- under this section during a 12-month period shall be counted
- against the amount of leave the eligible employee is entitled
- to under the FMLA and may be taken at anytime from the
- 29 beginning of the pregnancy to up to one year after birth,
- 30 adoption or placement.

- 1 (2) An eligible employee entitled to paid leave under
- 2 this act shall be paid, during the period of leave, the
- 3 eligible employee's full rate of pay the eligible employee
- 4 received before the period of leave commences or, if the rate
- of pay is based on an hourly rate, the weekly average
- 6 applicable during the four weeks before the period of leave
- 7 commences.
- 8 (3) An employer of an eligible employee entitled to paid
- 9 leave under this act may not, during the period of leave,
- 10 terminate, reduce or in any manner diminish the other
- 11 benefits or emoluments of employment to which the eligible
- 12 employee was entitled before the period of leave commences.
- 13 Section 4. Regulation.
- 14 The department may promulgate regulations necessary to
- 15 implement the provisions of this act.
- 16 Section 5. Effective date.
- 17 This act shall take effect in 60 days.
