AN ACT

Amending the act of February 9, 1999 (P.L.1, No.1), entitled "An 1 act providing for borrowing for capital facilities; conferring powers and duties on various administrative 3 agencies and officers; making appropriations; and making 4 repeals," further providing for the definition of 5 "redevelopment assistance capital project" and for 6 appropriation for and limitation on redevelopment assistance 7 capital projects. 9 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 10 11 Section 1. Paragraphs (2) and (3) of the definition of 12 "redevelopment assistance capital project" in section 302 of the 13 act of February 9, 1999 (P.L.1, No.1), known as the Capital Facilities Debt Enabling Act, amended October 25, 2013 (P.L.648, 14 15 No.77), are amended to read: 16 Section 302. Definitions. 17 The following words and phrases when used in this chapter

shall have the meanings given to them in this section unless the

context clearly indicates otherwise:

- 1 "Redevelopment assistance capital project." The design and
- 2 construction of a project which meets all of the following:

- 4 (2) Is a project which will generate substantial
- 5 increases in or maintain current levels of employment, tax
- 6 revenues or other measures of economic activity. This
- 7 paragraph includes:
- 8 (i) a community asset project; and
- 9 (ii) a housing project that will support and
- generate economic activity or provide housing to the
- 11 <u>veteran population of this Commonwealth</u>.
- 12 (3) Is a project that has a regional or
- 13 multijurisdictional impact or, in the case of housing, is
- part of a community revitalization plan or a plan to provide
- 15 <u>housing to the veteran population of this Commonwealth</u>.

- (c) Housing units. -- An amount not to exceed \$50,000,000 of
- 23 the amount under subsection (b) may be used for the construction
- 24 of housing units, provided that a minimum of \$20,000,000 be used
- 25 for the construction of units to house veterans who are
- 26 residents of this Commonwealth and homeless or in need of
- 27 <u>housing</u>.
