AN ACT

- Amending Title 75 (Vehicles) of the Pennsylvania Consolidated 1 Statutes, further providing for use of miscellaneous motor 2 vehicle business registration plates. 3 The General Assembly of the Commonwealth of Pennsylvania 4 5 hereby enacts as follows: Section 1. Section 1337 of Title 75 of the Pennsylvania 6 Consolidated Statutes is amended to read: § 1337. Use of "Miscellaneous Motor Vehicle Business" 8 9 registration plates. 10 (a) General rule. -- The department shall issue to owners of 11 miscellaneous motor vehicle businesses with established places 12 of business special registration plates which may be displayed 13 on vehicles operated on highways in lieu of registering each 14 vehicle individually. Registration plates issued under this 15 section may be displayed upon vehicles only as provided for each 16 of the following classes of miscellaneous motor vehicle 17 business:
- 18 (1) For a repair, detailing or towing business:
- 19 (i) upon vehicles being used in the conduct of the

1 repair or detailing business to retrieve, tow or deliver 2 other vehicles or parts; and 3 (ii) upon vehicles being repaired or detailed. (2) For a vehicle salvage dealer business: 4 5 upon vehicles being used in the conduct of the 6 vehicle salvage dealer's business to retrieve or deliver 7 vehicles, vehicle hulks, parts or materials; and 8 (ii) upon vehicles being transported on their own 9 wheels for the purpose of being dismantled or recycled. (3) For a transporter business upon vehicles being 10 transported on their own wheels in the conduct of the 11 12 transporter business. 13 (4) For a financier or collector-repossessor business: 14 upon vehicles being used to pick up vehicles 15 that are being repossessed; and 16 (ii) upon vehicles being repossessed. (5) For a watercraft trailer business: 17 18 (i) upon trailers used for the delivery of a new 19 boat to its purchaser; 20 (ii) upon trailers used for the transport of a used 21 boat which is to be resold by the dealer; and 22 (iii) upon trailers used for the transport of boats 23 by a dealer to or from another boat dealer, warehouse, 24 storage facility, boat show or repair facility or to and 25 from a location where a boat is to be demonstrated, 26 tested or inspected. 27 (6) For all classes of miscellaneous motor vehicle 28 businesses upon vehicles used for the personal pleasure or 29 use of the owner of the miscellaneous motor vehicle business or members of the owner's immediate family, or when the 30

- 1 business is a corporation, upon vehicles used for the
- 2 pleasure or use of not more than three officers or members of
- 3 the officer's immediate family or for the personal use of the
- 4 regular employees of the business when operated by the
- 5 employee.
- 6 All vehicles specified in paragraphs (1)(i), (2)(i), (4)(i) and
- 7 (6) must be titled in the name of the business or family member
- 8 and sales tax must be paid.
- 9 (b) Application for registration. -- Application for
- 10 registration in any of the "Miscellaneous Motor Vehicle
- 11 Business" classes shall be made upon a form provided by the
- 12 department and shall set forth the full name and business
- 13 address of the applicant and such other information as the
- 14 department shall require. The application shall be verified by
- 15 the oath or affirmation of the applicant or, if the applicant is
- 16 a partnership or a corporation, by a partner or officer.
- 17 (c) Classes of "Miscellaneous Motor Vehicle Business".--
- 18 (1) Repair or towing. -- Any person regularly engaged in
- 19 the business of mechanical or body repairs or towing for
- direct compensation of motor vehicles owned and operated by
- 21 other persons.
- 22 (2) Vehicle salvage dealer.--Any person regularly
- engaged in the business of acquiring and dismantling used,
- 24 wrecked, damaged, abandoned or salvage vehicles for the
- 25 purpose of selling the usable parts and selling the remaining
- vehicle hulk materials for recycling or processing.
- 27 (3) Transporter.--Any person regularly engaged in the
- business of transporting new or used vehicles on their own
- 29 wheels, owned by or in possession of a manufacturer or
- 30 dealer.

- (4) Financier or collector-repossessor.—Any person who is duly authorized by the Department of Banking to do business in this Commonwealth as a financier or collector-repossessor and who is regularly engaged in the business of financing sales, making loans on the security of vehicles or repossessing vehicles which are the subject of installment sales contracts as an independent contractor.
 - (5) Watercraft trailer dealer.—Any person regularly engaged in the business of selling watercraft and trailers used exclusively for the transport of the watercraft.
- (6) Automotive detailing. -- Any person regularly engaged in the business of performing an extremely thorough cleaning, polishing and waxing, both interior and exterior, of automobiles owned or in the possession of a manufacturer or dealer, to produce a show-quality appearance level.

 Section 2. This act shall take effect in 60 days.
