AN ACT

Amending Title 35 (Health and Safety) of the Pennsylvania Consolidated Statutes, providing for incentives for municipal 2 volunteers of fire companies and nonprofit emergency medical 3 services agencies. 4 5 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 6 7 Section 1. - 7 § 7901. Scope of chapter.
- 8 This chapter relates to incentives for municipal volunteers
- 9 of fire companies and nonprofit emergency medical services
- 10 <u>agencies</u>.
- 11 <u>§ 7902. Purpose.</u>
- 12 The purpose of this chapter is to authorize municipalities to
- 13 <u>enact a tax credit against an active volunteer's earned income</u>
- 14 <u>as a financial incentive to:</u>
- 15 (1) Acknowledge the value of and the absence of any
- 16 <u>public cost for volunteer fire protection and emergency</u>
- 17 medical services provided by active volunteers.
- 18 (2) Encourage individuals to volunteer or for former
- 19 <u>volunteers to consider rejoining as active volunteers in a</u>
- volunteer fire company or nonprofit emergency medical
- 21 services agency.
- 22 § 7903. Definitions.
- The following words and phrases when used in this chapter
- 24 shall have the meanings given to them in this section unless the
- 25 context clearly indicates otherwise:
- 26 "Active volunteer." A volunteer for a volunteer fire company
- 27 <u>or nonprofit emergency medical services agency who has complied</u>
- 28 with the requirements of the volunteer service credit program
- 29 and who is certified under section 7923 (relating to
- 30 certification).

- 1 <u>"Commissioner." The State Fire Commissioner of the</u>
- 2 Commonwealth.
- 3 "Earned income tax." A tax on earned income and net profits
- 4 <u>levied under Chapter 3 of the act of December 31, 1965</u>
- 5 (P.L.1257, No.511), known as The Local Tax Enabling Act.
- 6 <u>"Governing body." A county council, county board of</u>
- 7 commissioners, city council, borough council, incorporated town
- 8 <u>council</u>, <u>board of township commissioners</u>, <u>board of township</u>
- 9 supervisors, governing council of a home rule municipality or
- 10 optional plan municipality or a governing council of any similar
- 11 purpose government which may be created by statute after the
- 12 <u>effective date of this section and which has adopted a tax</u>
- 13 <u>credit under this chapter.</u>
- "Local Tax Enabling Act." The act of December 31, 1965
- 15 (P.L.1257, No.511), known as The Local Tax Enabling Act.
- 16 "Municipality." A city, borough, incorporated town or
- 17 township located in this Commonwealth.
- 18 "Nonprofit emergency medical services agency." As defined in
- 19 section 8103 (relating to definitions) and chartered as a
- 20 nonprofit corporation.
- 21 "Tax credit." The tax credit granted under section 7911
- 22 (relating to program authorization).
- 23 "Volunteer." A member of a volunteer fire company or a
- 24 nonprofit emergency medical services agency.
- 25 "Volunteer fire company." A nonprofit chartered corporation,
- 26 association or organization located in this Commonwealth that
- 27 provides fire protection services and may offer other voluntary
- 28 emergency services within this Commonwealth.
- 29 "Volunteer service credit program." The program established
- 30 under section 7921 (relating to volunteer service credit

- 1 program) to determine the active status of a volunteer.

- 8 § 7911. Program authorization.
- 9 (a) Establishment. -- A municipality that levies an earned
- 10 income tax may establish by ordinance a tax credit against an
- 11 individual's liability imposed under Chapter 3 of The Local Tax
- 12 Enabling Act for active service as a volunteer.
- 13 (b) Amount. -- A municipality shall set forth in the ordinance
- 14 the amount of the tax credit. If the total earned income tax
- 15 liability is less than the amount established, the tax credit
- 16 shall equal the tax liability.
- 17 (c) Public notice. -- At least 30 days prior to adoption of
- 18 the ordinance or resolution, the governing body shall give
- 19 public notice of its intent to adopt an ordinance or resolution
- 20 to establish a tax credit and conduct at least one public
- 21 hearing on the issue.
- 22 (d) Specific notice. -- A municipality that establishes a tax
- 23 <u>credit under this chapter shall notify the commissioner in the</u>
- 24 manner prescribed by the commissioner.
- 25 <u>§ 7912. Claim.</u>
- 26 (a) Eligibility. -- An individual who satisfies all of the
- 27 <u>following criteria may claim a tax credit established under</u>
- 28 section 7911 (relating to program authorization):
- 29 (1) The individual is subject to an earned income tax of
- 30 a municipality that has established a tax credit under

- 1 section 7911.
- 2 (2) The individual is certified under section 7923
- 3 (relating to certification).
- 4 (b) Return. -- An active volunteer may claim a tax credit
- 5 provided for under this subchapter when filing a joint return.
- 6 The tax return form shall provide a mechanism for separating the
- 7 <u>liability of an individual for any earned income tax imposed by</u>
- 8 the school district of residence from the liability of an
- 9 <u>individual for any earned income tax imposed by the</u>
- 10 municipality.
- 11 § 7913. Limitations.
- 12 A tax credit established under this subchapter may be used
- 13 <u>against the active volunteer's earned income tax for the current</u>
- 14 taxable year and every year thereafter. The tax credit
- 15 <u>established under this subchapter shall remain in effect until</u>
- 16 the governing body of the municipality repeals the tax credit.

- 24 § 7921. Volunteer service credit program.
- 25 (a) Establishment. -- The governing body may establish a
- 26 volunteer service credit program that establishes the annual
- 27 requirements for the certification of a volunteer in active
- 28 service at a volunteer fire company or a nonprofit emergency
- 29 medical services agency.
- 30 (b) Activities. -- The volunteer service credit program shall

- 1 consider the following activities in determining credit toward a
- 2 certification of active service:
- 3 (1) The number of emergency calls to which a volunteer
- 4 <u>responds</u>.
- 5 (2) The level of training and participation in formal
- 6 training and drills for a volunteer.
- 7 (3) The total amount of time expended by a volunteer on
- 8 <u>administrative and other support services, including</u>
- 9 <u>fundraising and facility or equipment maintenance.</u>
- 10 (4) The involvement in other events or projects that aid
- the financial viability, emergency response or operational
- 12 <u>readiness of a volunteer fire company or an emergency medical</u>
- 13 <u>services agency.</u>
- 14 (c) Guidelines. -- The governing body and the chief of a
- 15 <u>volunteer fire company and the supervisor or chief of an</u>
- 16 <u>emergency medical services agency or their designees shall adopt</u>
- 17 guidelines, including forms and applications, necessary to
- 18 implement this section.
- 19 (d) Eligibility List. -- A notarized list of eligible active
- 20 volunteers shall be submitted to the governing body, no later
- 21 than 45 days before tax notices are to be distributed, by the
- 22 <u>following:</u>
- 23 (1) The chief of a volunteer fire company, where
- 24 applicable.
- 25 (2) The supervisor or chief of a nonprofit emergency
- 26 medical services agency, where applicable.
- 27 § 7922. Service record.
- 28 (a) Log. -- The chief of a volunteer fire company or the
- 29 <u>supervisor or chief of a nonprofit emergency medical services</u>
- 30 agency or their designees shall establish and maintain a service

- 1 log that documents the activities of each volunteer that qualify
- 2 for credit toward active service under the volunteer service
- 3 <u>credit program and the calculation of the total credits earned</u>
- 4 <u>for each volunteer in the volunteer fire company or nonprofit</u>
- 5 <u>emergency medical services agency.</u>
- 6 (b) Review. -- Service logs established and maintained by
- 7 <u>volunteer fire companies or nonprofit emergency medical services</u>
- 8 agencies shall be subject to periodic review by the
- 9 <u>commissioner</u>, the Auditor General, the governing body where the
- 10 volunteer fire company or emergency medical services agency is
- 11 <u>located and the governing body where the volunteer fire company</u>
- 12 <u>or nonprofit emergency medical services agency provides</u>
- 13 <u>services.</u>
- 14 § 7923. Certification.
- 15 (a) Self-certification. -- The active volunteer shall sign and
- 16 <u>submit an application to the chief of the volunteer fire company</u>
- 17 or the supervisor or chief of the nonprofit emergency medical
- 18 services agency where the volunteer serves.
- 19 (b) Local sign-off.--The chief and another officer of the
- 20 volunteer fire company, the supervisor or chief and another
- 21 officer of the nonprofit emergency medical services agency shall
- 22 sign the application attesting to the individual's status as an
- 23 active volunteer. The application shall then be forwarded to the
- 24 municipality, as appropriate, for final review and processing.
- 25 § 7924. Rejection and appeal.
- 26 (a) General rule. -- A governing body that establishes a tax
- 27 <u>credit under this chapter shall adopt, by ordinance, a process</u>
- 28 for rejecting a claim by an active volunteer who does not
- 29 satisfy all of the criteria established under this chapter for
- 30 each type of tax credit provided under this chapter.

- 1 (b) Appeal. -- An active volunteer shall have the right to
- 2 appeal a claim that has been rejected by a governing body. The
- 3 governing body shall establish, by ordinance, the procedure by
- 4 which a rejected claim can be appealed.

- 9 § 7931. Penalties for false reporting.
- 10 The following shall apply:
- 11 (1) Any person who knowingly makes or conspires to make
- 12 <u>a false service record report under this chapter commits a</u>
- 13 <u>misdemeanor of the first degree punishable by a fine of</u>
- 14 <u>\$2,500.</u>
- 15 (2) Any person who knowingly provides or conspires to
- 16 provide false information that is used to compile a service
- 17 record report under this chapter commits a misdemeanor of the
- first degree punishable by a fine of \$2,500.
- 19 Section 2. This act shall take effect in 60 days.
