1 2 3 4	Amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in riot, disorderly conduct and related offenses, providing for the offense of unlawful treatment of elephants.
5	The General Assembly of the Commonwealth of Pennsylvania
6	hereby enacts as follows:
7	Section 1. Title 18 of the Pennsylvania Consolidated
8	Statutes is amended by adding a section to read:
9	<u>§ 5511.4. Unlawful treatment of elephant.</u>
10	(a) Offense definedIt shall be unlawful for any person
11	who houses, possesses, is in contact with or travels with an
12	elephant utilized in a circus or traveling show within this
13	Commonwealth to engage in any of the following:
14	(1) Use of any implement on an elephant that may
15	reasonably result in harm to the elephant, including, but not
16	limited to, the damage, scarring or breakage of an elephant's
17	<u>skin.</u>
18	(2) Possession of any implement or device that may

1	reasonably result in harm, damage, scarring or breakage of
2	<u>skin to an elephant.</u>
3	(3) Use of a chain or similar device to restrain an
4	elephant, except if utilized for the shortest amount of time
5	necessary to provide actual medical treatment.
6	(b) GradingA person who violates this section commits a
7	misdemeanor of the second degree.
8	(c) DefinitionsThe following words and phrases when used
9	in this section shall have the meanings given to them in this
10	subsection unless the context clearly indicates otherwise:
11	"Circus." A Class C licensee under the Animal Welfare Act
12	(Public Law 89-544, 7 U.S.C. § 2131 et seq.), and the
13	regulations and standards adopted pursuant to that act, that
14	offers a performance by a live animal, clown or acrobat.
15	"Implement." An implement or device that is used, purchased,
16	contrived for or constructed for the purpose of poking,
17	striking, hitting, stabbing, piercing, pinching or other
18	physical contact of an elephant. The term includes, but is not
19	limited to, a bullhook, ankus or other similar device.
20	"Traveling show." A circus, public show, trade show,
21	photographic opportunity, carnival, city or county fair,
22	agricultural fair, ride, parade, race, performance or a similar
23	undertaking in which elephants do not permanently reside or that
24	moves elephants from location to location, but not including the
25	transportation of an elephant for the purpose of obtaining
26	required medical services for an elephant or for the exchange of
27	an elephant between sanctuaries.
28	Section 2. This act shall take effect in 60 days.
