## AN ACT

JONES MEMORIAL HIGHWAY; DESIGNATING A PORTION OF 9 STATE ROUTE 254 IN NORTHUMBERLAND COUNTY AS THE STAFF 10 SERGEANT THOMAS ALLEN BAYSORE MEMORIAL HIGHWAY; DESIGNATING 11 THE PORTION OF STATE ROUTE 443 WITHIN THE MUNICIPAL 12 BOUNDARIES OF ORWIGSBURG BOROUGH, SCHUYLKILL COUNTY, AS THE 13 CORPORAL DAVID F. HEISER MEMORIAL HIGHWAY; DESIGNATING A 14 PORTION OF STATE ROUTE 15 IN LYCOMING COUNTY AS THE KELLY RAE 15 MERTES DUI AWARENESS MEMORIAL HIGHWAY; DESIGNATING A PORTION 16 OF STATE ROUTE 153 FROM SEGMENT 80 TO SEGMENT 310 IN 17 CLEARFIELD COUNTY AS THE AUSTIN M. HARRIER MEMORIAL HIGHWAY; 18 DESIGNATING A PORTION OF STATE ROUTE 422 IN LEBANON COUNTY AS 19 THE OFFICER MICHAEL H. WISE II MEMORIAL HIGHWAY; DESIGNATING 20 EXIT 26 FROM THE MON-FAYETTE EXPRESSWAY IN LUZERNE TOWNSHIP, 21 FAYETTE COUNTY, AS THE RONALD F. DESALVO MEMORIAL 22 INTERCHANGE; DESIGNATING A PORTION OF DAVISVILLE ROAD IN 23 UPPER MORELAND TOWNSHIP, MONTGOMERY COUNTY, FROM STATE ROUTE 24 611, ALSO KNOWN AS YORK ROAD, TO TERWOOD ROAD AS THE PFC 25 ROBERT S. ALEXANDER MEMORIAL HIGHWAY; AND DESIGNATING A 26 PORTION OF STATE ROUTE 22/322 IN JUNIATA COUNTY AS THE 27

- 1 HONORABLE DANIEL F. CLARK MEMORIAL HIGHWAY.
- 2 The General Assembly of the Commonwealth of Pennsylvania
- 3 hereby enacts as follows:
- 4 Section 1. Lance Corporal Brandon J. Van Parys Memorial Road.
- 5 (a) Findings.--The General Assembly finds and declares as
- 6 follows:
- 7 (1) Brandon J. Van Parys was born in Norristown,
- 8 Pennsylvania, on November 2, 1986, and, in 2005, graduated
- 9 from Northwestern Lehigh High School, New Tripoli.
- 10 (2) After high school, he attended Lehigh Career
- 11 Technical Institute where he took courses in law enforcement.
- 12 (3) In November 2005, motivated by the terrorist attacks
- on September 11, 2001, to serve his country, he enlisted in
- 14 the United States Marine Corps.
- 15 (4) Lance Corporal Van Parys was a member of the 3rd
- 16 Battalion, 6th Marine Regiment, 2nd Marine Division, II
- 17 Marine Expeditionary Force, Camp Lejeune, North Carolina.
- 18 (5) On February 5, 2007, in Anbar Province, Iraq, Lance
- 19 Corporal Van Parys was tragically killed by a rocket-
- 20 propelled grenade while his unit was attempting to secure an
- 21 area along the Euphrates River.
- 22 (6) Lance Corporal Van Parys heroically paid the supreme
- 23 sacrifice for the country he loved.
- 24 (7) Lance Corporal Van Parys was posthumously awarded
- 25 the Purple Heart for his courageous service to his country.
- He is survived by his father, Alan, and his wife, Tammy; his
- 27 mother, Catherine Hearn and her husband, Gregory; his
- 28 brothers, Christopher Van Parys, Daniel Van Parys, Samuel
- Hearn and Jesse Hearn; and his sister, Ashley Hearn.
- 30 (b) Designation. -- The portion of State Route 309 North in

- 16 THE LEAD BOAT IN A NEW CLASS OF NUCLEAR POWERED, FAST ATTACK
- 17 SUBMARINES DESIGNED TO BE A WEAPON OF DETERRENCE AT THE
- 18 HEIGHT OF THE COLD WAR AND WAS CONSIDERED THE MOST ADVANCED
- 19 NAVAL VESSEL OF ITS TIME.
- 20 (3) AT 9:03 A.M., THE USS SKYLARK RECEIVED A GARBLED
- TRANSMISSION OVER THE UNDERWATER TELEPHONE REPORTING THAT THE
- 22 USS THRESHER WAS EXPERIENCING MINOR DIFFICULTIES.
- 23 (4) THE USS THRESHER AND THE 129 MEN IT CARRIED,
- 24 INCLUDING 17 CIVILIANS, NEVER RETURNED TO THE SURFACE.
- 25 (5) THE LOSS OF THE USS THRESHER IS ONE OF THE WORST
- 26 SUBMARINE DISASTERS THE WORLD HAS EVER KNOWN.
- 27 (6) AFTER THE TRAGEDY, THE NAVY CREATED SUBSAFE, A
- 28 SAFETY PROGRAM THAT HAS ENSURED THAT NO SUBMARINE PASSING
- 29 THROUGH THIS PROCESS EVER SUFFERS A SIMILAR FATE.
- 30 (7) PETTY OFFICER THOMAS JOHNSON WAS ABOARD THE USS

- 1 THRESHER THAT DAY AND SACRIFICED HIS LIFE IN SERVICE TO HIS
- 2 COUNTRY.

- 19 (3) CAPTAIN JONES WAS AWARDED THE BRONZE STAR FOR HIS
- 20 PERFORMANCE DURING DEPLOYMENT TO IRAQ IN 2008 TO 2009.
- 21 (4) IN MAY 2013, CAPTAIN JONES COMPLETED THE SPECIAL
- FORCES QUALIFICATION COURSE TO JOIN THE RANKS OF THE ARMY
- 23 SPECIAL FORCES, KNOWN AS THE GREEN BERETS, AND WAS DEPLOYED
