## AN ACT

Amending Titles 42 (Judiciary and Judicial Procedure) and 53

(Municipalities Generally) of the Pennsylvania Consolidated 2 Statutes, in selection and retention of judicial officers, further providing for continuing education requirement; and, in municipal police education and training, further providing for powers and duties of Municipal Police Officers' Education 5 6 and Training Commission. 7 8 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 10 Section 1. Section 3118(a) of Title 42 of the Pennsylvania Consolidated Statutes is amended to read: 11 12 § 3118. Continuing education requirement. 13 Magisterial district judges. --(a) 14 (1) Every magisterial district judge shall complete a 15 continuing education program each year equivalent to not less 16 than 32 hours per year in such courses or programs as are 17 approved by the board[.], including, but not limited to, the 18 identification of mental illness and intellectual disabilities and the availability of diversionary options for 19

- 2 <u>(2)</u> If a magisterial district judge fails to meet these
- 3 continuing education requirements, such judge shall be
- 4 subject to suspension by the Supreme Court until such time as
- 5 evidence of compliance with such requirements is submitted by
- 6 the board, but in no event longer than six months at which
- 7 time the failure to meet the continuing education
- 8 requirements shall be grounds for the Supreme Court, after a
- 9 hearing, to declare a vacancy in that district.
