AN ACT

- 1 Providing for release of information by coroners and medical examiners.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the Release of
- 7 Coroner and Medical Examiner Information Act.
- 8 Section 2. Definitions.
- 9 The following words and phrases when used in this act shall
- 10 have the meanings given to them in this section unless the
- 11 context clearly indicates otherwise:
- 12 "County." A county of this Commonwealth THE FIRST CLASS,
- 13 SECOND CLASS, SECOND CLASS A, THIRD CLASS, FOURTH CLASS, FIFTH
- 14 CLASS, SIXTH CLASS, SEVENTH CLASS OR EIGHTH CLASS, including a
- 15 county within which is located a city of the first class or with
- 16 which a city of the first class is coextensive.

- 1 Section 3. Investigation information.
- 2 (a) General rule. -- Except NOTWITHSTANDING THE ACT OF
- 3 FEBRUARY 14, 2008 (P.L.6, NO.3), KNOWN AS THE RIGHT-TO-KNOW LAW,

- 4 AND EXCEPT as provided in subsection (b), the following apply to
- 5 public release of information by a coroner or medical examiner:
- 6 (1) Following an investigation by a coroner or medical
- 7 examiner to determine the cause of any death in this
- 8 Commonwealth, the coroner or medical examiner shall not
- 9 release to the public the name of the deceased and OR the
- 10 cause and manner of death unless the release is in accordance
- 11 with the requirements under paragraph (2).
- 12 (2) Release of the information under paragraph (1) may
- not occur until either notification of the next of kin of the
- 14 deceased individual is confirmed or 72 hours have elapsed
- following the determination of the identity of the deceased
- 16 individual and OR the cause and manner of the death,
- 17 whichever occurs first.
- 18 (b) Exception. This section shall not apply in cases of a <--
- 19 public health emergency as determined by the coroner or medical-
- 20 examiner.
- 21 (B) PUBLIC HEALTH EMERGENCIES. -- NOTWITHSTANDING THE
- 22 PROVISIONS OF SUBSECTION (A), A CORONER OR MEDICAL EXAMINER MAY
- 23 RELEASE TO THE PUBLIC THE NAME OF THE DECEASED AND THE CAUSE AND
- 24 MANNER OF DEATH AT ANY TIME IF THE CORONER OR MEDICAL EXAMINER
- 25 DETERMINES THAT THE RELEASE IS NECESSARY TO AVERT A PUBLIC
- 26 HEALTH EMERGENCY.
- 27 Section 4. Applicability.
- This act shall apply in each county of this Commonwealth.
- 29 Section 5. Effective date.
- 30 This act shall take effect in 60 days.
