13	(2) A former or retired justice, judge or magisterial
14	district judge of this Commonwealth who is serving as a
15	senior judge or senior magisterial district judge as provided
16	or prescribed by law; or not serving as a senior judge or
17	senior magisterial district judge but meets the following

1 criteria:

(i) has served as a magisterial district judge,
judge or justice[, whether or not continuously or on the
same court,] by election or appointment [for an aggregate
period equaling a full term of office];

6 (ii) has not been defeated for reelection or 7 retention;

8 (iii) has not been convicted of, pleaded nolo 9 contendere to or agreed to an Accelerated Rehabilitative 10 Disposition or other probation without verdict program 11 relative to any misdemeanor or felony offense under the 12 laws of this Commonwealth or an equivalent offense under 13 the laws of the United States or one of its territories 14 or possessions, another state, the District of Columbia, 15 the Commonwealth of Puerto Rico or a foreign nation;

16 (iv) has not resigned a judicial commission to avoid 17 having charges filed or to avoid prosecution by Federal, 18 State or local law enforcement agencies or by the 19 Judicial Conduct Board;

20 (v) has not been removed from office by the Court of
21 Judicial Discipline; and

22 (vi) is a resident of this Commonwealth.
