Designating the Conodoguinet Bridge on that portion of State Route 641 over the Conodoquinet Creek, Hopewell Township, 2 Cumberland County, as the Army Pfc. Harold "Sam" E. Barrick Memorial Bridge-; DESIGNATING THE BRIDGE LOCATED ON THAT PORTION OF STATE ROUTE 865, OVER THE RAILROAD TRACKS AND MAIN 5 STREET IN BELLWOOD, BLAIR COUNTY, AS THE DOMINEC M. "PATSY" 6 PADULA MEMORIAL BRIDGE; DESIGNATING THE BRIDGE ON THAT 7 PORTION OF STATE ROUTE 940 OVER TOBYHANNA CREEK (POCONO LAKE) IN TOBYHANNA TOWNSHIP, MONROE COUNTY, AS THE SULLIVAN BRIDGE; 9 DESIGNATING A BRIDGE ON THAT PORTION OF STATE ROUTE 155 OVER 10 THE ALLEGHENY RIVER, PORT ALLEGANY BOROUGH AND LIBERTY 11 TOWNSHIP, MCKEAN COUNTY, AS THE PORT ALLEGANY VETERANS 12 MEMORIAL BRIDGE; DESIGNATING A BRIDGE ON THAT PORTION OF 13 LOCAL ROUTE T-325 OVER THE ALLEGHENY RIVER, COUDERSPORT 14 BOROUGH, POTTER COUNTY, AS THE LT. WILLIAM E. DAISLEY, JR., 15 16 MEMORIAL BRIDGE; DESIGNATING THE BRIDGE ON THAT PORTION OF STATE ROUTE 3005 OVER THE OUTLET OF LILY LAKE, CONYNGHAM 17 TOWNSHIP, LUZERNE COUNTY, AS THE SENIOR OFFICER ERIC J. 18 WILLIAMS MEMORIAL BRIDGE; DESIGNATING THE BRIDGE ON THAT 19 PORTION OF STATE ROUTE 3005 OVER THE WEST BRANCH OF THE 20 SUSQUEHANNA RIVER, GREENWOOD TOWNSHIP, CLEARFIELD COUNTY, AS 21 THE 1ST LIEUTENANT WENDELL ELBERT ROSS MEMORIAL BRIDGE; 22 23 DESIGNATING A BRIDGE ON THAT PORTION OF STATE ROUTE 3007 OVER THE REDBANK CREEK, SUMMERVILLE BOROUGH, JEFFERSON COUNTY, AS 24 THE SUMMERVILLE VETERANS MEMORIAL BRIDGE; AND RENAMING THE 25 BRIDGE ON THAT PORTION OF U.S. ROUTE 219 OVER U.S. ROUTE 422 26 IN EBENSBURG BOROUGH, CAMBRIA COUNTY, AS THE ALEXANDER MILLER 27

- 1 ABERCROMBIE MEMORIAL BRIDGE.
- 2 The General Assembly of the Commonwealth of Pennsylvania
- 3 hereby enacts as follows:
- 4 Section 1. Army Pfc. Harold "Sam" E. Barrick Memorial Bridge.
- 5 (a) Findings.--The General Assembly finds that:
- 6 (1) Harold "Sam" E. Barrick was born on December 16,
- 7 1947, in Newville, Cumberland County, and graduated from Big
- 8 Spring High School in 1965.
- 9 (2) He joined the United States Army and entered service
- in August 1967 and served with the American division in
- 11 Vietnam beginning January 1968.
- 12 (3) Pfc. Harold "Sam" E. Barrick was killed in action in
- 13 Vietnam on April 8, 1968.
- 14 (4) Prior to his death, Pfc. Barrick was awarded the
- 15 National Defense Service Medal, the Vietnam Service Medal and
- 16 the Vietnam Campaign Ribbon.
- 17 (5) He also received the Bronze Star Medal, the Purple
- 18 Heart and the Good Conduct Medal, which were awarded
- 19 posthumously.
- 20 (b) Designation. -- The Conodoguinet Bridge located on State
- 21 Route 641 in Hopewell Township, Cumberland County, over the
- 22 Conodoquinet Creek is hereby designated the Army Pfc. Harold
- 23 "Sam" E. Barrick Memorial Bridge.
- 24 (c) Signs. -- The Department of Transportation shall erect and
- 25 maintain appropriate signs displaying the name of the bridge to
- 26 traffic in both directions on the bridge.

- 14 (V) CENTRAL EUROPE.
- 15 (4) ADDITIONALLY, HE EARNED THE FOLLOWING MEDALS:
- 16 (I) GOOD CONDUCT MEDAL.
- 17 (II) AMERICAN THEATER SERVICE MEDAL.
- 18 (III) EUROPEAN-AFRICAN-MIDDLE EASTERN SERVICE MEDAL.
- 19 (5) DOMINEC PADULA WAS BORN IN THE RIEGHTOWN SECTION OF
- 20 BELLWOOD ON FEBRUARY 23, 1919, OF IMMIGRANT PARENTS FROM
- 21 AOUAVIVA D'ISERNIA, ITALY. HE MARRIED EVELYN SNYDER AND WAS
- 22 THE FATHER OF MICHAEL RICHARD PADULA AND DAVID ALLEN PADULA,

- 29 CABOOSE SHOPS AND THE SAMUEL REA SHOPS IN HOLLIDAYSBURG. HE
- 30 WAS EMPLOYED FROM MARCH 31, 1941, WITH A GAP IN EMPLOYMENT

- 1 FOR WORLD WAR II, UNTIL HE RETIRED ON MAY 27, 1980, WITH OVER
- 2 39 YEARS OF EMPLOYMENT.
- 3 (B) DESIGNATION.--THE BRIDGE LOCATED ON THAT PORTION OF
- 4 STATE ROUTE 865, OVER THE RAILROAD TRACKS AND MAIN STREET IN
- 5 BELLWOOD, BLAIR COUNTY, IS DESIGNATED THE DOMINEC M. "PATSY"
- 6 PADULA MEMORIAL BRIDGE.
- 7 (C) SIGNS.--THE DEPARTMENT OF TRANSPORTATION SHALL ERECT
- 8 AND MAINTAIN APPROPRIATE SIGNS TO INDICATE THE DESIGNATION
- 9 UNDER SUBSECTION (B).
- 10 SECTION 3. SULLIVAN BRIDGE.
- 11 (A) FINDINGS AND DECLARATIONS. -- THE GENERAL ASSEMBLY FINDS
- 12 AND DECLARES AS FOLLOWS:
- 13 (1) IN 1779, GENERAL GEORGE WASHINGTON ORDERED GENERAL
- 14 JOHN SULLIVAN TO TAKE APPROXIMATELY 30% OF THE CONTINENTAL
- 15 ARMY INTO UPSTATE NEW YORK. THE PURPOSE WAS TO QUASH THE
- 16 ALIGNED BRITISH AND SIX NATIONS OF THE IROQUOIS, WHO WERE
- 17 INVADING WILKES-BARRE, KILLING HUNDREDS OF MILITARY AND
- 18 CIVILIANS. THE ULTIMATE GOAL OF THE BRITISH WAS TO GAIN
- 19 CONTROL OF THE SUSOUEHANNA RIVER FROM UPSTATE NEW YORK TO
- 20 BALTIMORE, SPLITTING THE COLONIES TO END THE REBELLION.
- 21 (2) AS THE ARMY GATHERED IN EASTON, THERE WAS NO ROAD
- 22 OVER THE POCONO MOUNTAINS TO ACCOMMODATE THOUSANDS OF TROOPS,
- 23 HORSES, WAGONS, CANNONS AND SUPPLIES. TWO REGIMENTS OF 500
- 24 MILITARY ROAD BUILDERS ACCOMPLISHED THE TASK IN JUST SIX
- 25 WEEKS, FROM TANNERSVILLE TO WILKES-BARRE. IT WAS A DESOLATE
- 26 AREA OF FORESTS AND SWAMPS, REQUIRING A HERCULEAN EFFORT WITH
- 27 JUST HAND TOOLS. THE WORST SECTION, KNOWN AS THE GREAT SWAMP,
- 28 WAS LOCATED IN WHAT IS NOW TOBYHANNA TOWNSHIP. THE ONLY
- 29 BRIDGE THE MILITARY ROAD BUILDERS NEEDED TO CONSTRUCT FOR THE
- 30 NEW ROAD WAS OVER THE TOBYHANNA CREEK. IT WAS IMMEDIATELY

- 1 NAMED SULLIVAN BRIDGE BY THE CONSTRUCTION ARMY. THROUGH THE
- 2 YEARS, THE BRIDGE NAMING WAS FORGOTTEN AND SHOULD RIGHTFULLY
- 3 BE RESTORED.
- 4 (3) SULLIVAN'S EXPEDITION WAS A SUCCESS, REMARKABLY WITH
- 5 FEWER THAN 50 FATALITIES. IT STOPPED THE BRITISH IN THEIR
- 6 TRACKS, CONTRIBUTING SIGNIFICANTLY TO THE BIRTH OF OUR
- 7 NATION. EOUALLY IMPRESSIVE IS THAT THE NEW ROAD, SULLIVAN'S
- 8 TRAIL OVER THE POCONO MOUNTAIN, OPENED THE REGION TO
- 9 SETTLEMENT AND DEVELOPMENT BY CONNECTING NORTHEASTERN
- 10 PENNSYLVANIA AND UPSTATE NEW YORK TO THE PHILADELPHIA AREA
- 11 AND ITS PORT.
- 12 (4) TODAY, SULLIVAN BRIDGE CONTINUES TO SIGNIFICANTLY
- 13 SERVE THE REGION. STATE ROUTE 940 PROVIDES IMPORTANT ACCESS
- 14 TO WESTERN MONROE COUNTY AND POINTS BEYOND. IT SERVES AS THE
- MAJOR ALTERNATIVE TO INTERSTATE 80 IN CASES OF EMERGENCIES ON
- 16 THE HEAVILY TRAVELED INTERSTATE HIGHWAY. IT IS AT THE CENTER
- 17 OF RECREATIONAL TOURISM FOR THE POCONOS, ALLOWING THOUSANDS
- 18 TO ENJOY THE STREAMS, LAKES, FORESTS AND ALL THAT ABOUNDS IN
- 19 THE AREA.
- 20 (5) THE BRIDGE, NAMED FOR GENERAL JOHN SULLIVAN,
- 21 REPRESENTS THE NORTHEASTERN PENNSYLVANIA REGION'S VITAL ROLE
- 22 IN PRESERVING OVER TIME OUR NATION'S INDEPENDENCE.
- 23 (B) DESIGNATION.--THE BRIDGE LOCATED ON THAT PORTION OF
- 24 STATE ROUTE 940, OVER TOBYHANNA CREEK (POCONO LAKE) IN TOBYHANNA
- 25 TOWNSHIP, MONROE COUNTY, IS HEREBY DESIGNATED THE SULLIVAN
- 26 BRIDGE.
- 27 (C) SIGNS.--THE DEPARTMENT OF TRANSPORTATION SHALL ERECT AND
- 28 MAINTAIN APPROPRIATE SIGNS TO INDICATE THE DESIGNATION UNDER
- 29 SUBSECTION (B).

- 16 SCHOLAR, ROLE MODEL AND ATHLETE AT COUDERSPORT AREA HIGH
- 17 SCHOOL.
- 18 (2) LT. DAISLEY ACCEPTED APPOINTMENT TO THE U.S. NAVAL
- 19 ACADEMY AND GRADUATED WITH HIGH HONORS.
- 20 (3) LT. DAISLEY WAS AN A-6 PILOT AND LANDING SIGNAL
- 21 OFFICER ASSIGNED TO ATTACK SQUADRON 34.
- 22 (4) ON MARCH 15, 1993, LT. DAISLEY AND LIEUTENANT
- 23 COMMANDER FRED D. DILLINGHAM WERE CONDUCTING AN F-14
- 24 FAMILIARIZATION FLIGHT AS PART OF A TRAINING EXERCISE OFF THE
- 25 COAST OF NORTH CAROLINA AND THEIR PLANE FAILED TO RETURN.

- 8 ROSS WAS KILLED BY SNIPER FIRE IN ITALY ON FEBRUARY 11, 1944.
- 9 (B) DESIGNATION.--THE BRIDGE LOCATED ON STATE ROUTE 3005 IN
- 10 GREENWOOD TOWNSHIP, CLEARFIELD COUNTY, OVER THE WEST BRANCH OF
- 11 THE SUSQUEHANNA RIVER IS HEREBY DESIGNATED THE 1ST LIEUTENANT

- 1 BORN MAY 7, 1921, IN KILSYTH, SCOTLAND.
- 2 (2) TECHNICAL SERGEANT ABERCROMBIE'S FAMILY ARRIVED IN
- 3 THE UNITED STATES APRIL 23, 1923.
- 4 (3) TECHNICAL SERGEANT ABERCROMBIE ATTENDED EBENSBURG-
- 5 CAMBRIA HIGH SCHOOL FOR ONE YEAR BEFORE ENLISTING IN THE
- 6 UNITED STATES ARMY SEPTEMBER 9, 1942.
- 7 (4) TECHNICAL SERGEANT ABERCROMBIE ENTERED ACTIVE
- 8 MILITARY SERVICE SEPTEMBER 20, 1942.
- 9 (5) TECHNICAL SERGEANT ABERCROMBIE COMPLETED AIRBORNE
- 10 TRAINING AND SERVED IN ALASKA BEFORE JOINING THE ALLIED
