"Electric or electronic incapacitation device." A portable 11 12 device which is designed or intended by the manufacturer to be 13 used, offensively or defensively, to temporarily immobilize or 14 incapacitate persons by means of electric pulse or current, including devices operated by means of carbon dioxide 15 16 propellant. The term does not include cattle prods, electric 17 fences or other electric devices when used in agricultural, 18 animal husbandry or food production activities.

19 "Emergency medical services personnel." The term includes, 20 but is not limited to, doctors, residents, interns, registered 21 nurses, licensed practical nurses, nurse aides, ambulance 22 attendants and operators, paramedics, emergency medical 23 technicians and members of a hospital security force while 24 working within the scope of their employment.

25 <u>"Municipality." A city, borough, incorporated town, township</u>
26 <u>or home rule municipality.</u>

27 Section 2. This act shall take effect in 60 days.
