1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
2 Statutes, in registration of vehicles, further providing for
3 REGISTRATION AND CERTIFICATE OF TITLE REQUIRED AND FOR <--
4 display of registration plate.

5 The General Assembly of the Commonwealth of Pennsylvania
6 hereby enacts as follows:

7 ~~Section 1. Section 1332(d) of Title 75 of the Pennsylvania <--

9 SECTION 1. SECTION 1301(D) OF TITLE 75 OF THE PENNSYLVANIA <--
10 CONSOLIDATED STATUTES IS AMENDED TO READ:

11 § 1301. REGISTRATION AND CERTIFICATE OF TITLE REQUIRED.

13 (D) PENALTY.--ANY PERSON VIOLATING THE PROVISIONS OF
14 SUBSECTION (A) IS GUILTY OF A SUMMARY OFFENSE AND SHALL, UPON
15 CONVICTION, BE SENTENCED TO PAY A FINE OF \$75 OR DOUBLE THE
16 REGISTRATION FEE, WHICHEVER IS GREATER, EXCEPT WHEN THE VEHICLE

1 WAS PREVIOUSLY REGISTERED IN THIS COMMONWEALTH WITHIN 60 DAYS OF  
2 THE COMMISSION OF THE OFFENSE WHEREUPON THE FINE SHALL BE \$25.  
3 IN THE CASE OF A MOTOR CARRIER VEHICLE OTHER THAN A TRAILER, THE  
4 FINE SHALL BE \$50 IF THE MOTOR CARRIER VEHICLE WAS PREVIOUSLY  
5 REGISTERED IN THIS COMMONWEALTH WITHIN 60 DAYS OF THE COMMISSION  
6 OF THE OFFENSE OR, IF THE REGISTRATION OCCURS OUTSIDE THE 60-DAY  
7 PERIOD, THE FINE SHALL BE DOUBLE THE REGISTRATION FEE FOR THE  
8 MAXIMUM WEIGHT AT WHICH THE VEHICLE COULD HAVE BEEN REGISTERED  
9 IN THIS COMMONWEALTH. NOTWITHSTANDING ANY OTHER PROVISION OF  
10 LAW, 100% OF THE FINE COLLECTED UNDER THIS SUBSECTION SHALL BE  
11 PAYABLE TO THE COMMONWEALTH FOR DEPOSIT IN THE MOTOR LICENSE  
12 FUND.

13 SECTION 2. SECTION 1332(D) OF TITLE 75 IS REPEALED:

14 § 1332. Display of registration plate.

16 [(d) Validating registration stickers.--Validating  
17 registration stickers shall not be issued or required to be  
18 displayed.]
