1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
2 Statutes, in registration of vehicles, further providing for
3 ~~registration and certificate of title required and for~~ <--
4 display of registration plate.

5 The General Assembly of the Commonwealth of Pennsylvania
6 hereby enacts as follows:

7 ~~Section 1. Section 1301(d) of Title 75 of the Pennsylvania~~ <--
8 ~~Consolidated Statutes is amended to read:~~

9 ~~§ 1301. Registration and certificate of title required.~~

11 ~~(d) Penalty. Any person violating the provisions of~~
12 ~~subsection (a) is guilty of a summary offense and shall, upon~~
13 ~~conviction, be sentenced to pay a fine of \$75 or double the~~
14 ~~registration fee, whichever is greater, except when the vehicle~~
15 ~~was previously registered in this Commonwealth within 60 days of~~
16 ~~the commission of the offense whereupon the fine shall be \$25.~~

1 ~~In the case of a motor carrier vehicle other than a trailer, the~~
2 ~~fine shall be \$50 if the motor carrier vehicle was previously~~
3 ~~registered in this Commonwealth within 60 days of the commission~~
4 ~~of the offense or, if the registration occurs outside the 60 day~~
5 ~~period, the fine shall be double the registration fee for the~~
6 ~~maximum weight at which the vehicle could have been registered~~
7 ~~in this Commonwealth. Notwithstanding any other provision of~~
8 ~~law, 100% of the fine collected under this subsection shall be~~
9 ~~payable to the Commonwealth for deposit in the Motor License~~
10 ~~Fund.~~
