AN ACT

- 1 Prohibiting the use of sick time by public employees for campaign activities.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the Sick Time
- 7 Abuse Prevention Act.
- 8 Section 2. Definitions.
- 9 The following words and phrases when used in this act shall
- 10 have the meanings given to them in this section unless the
- 11 context clearly indicates otherwise:
- 12 "Campaign activities." Activities intended to influence the
- 13 outcome of an election for public office, including, but not
- 14 limited to:
- 15 (1) campaigning;
- 16 (2) canvassing;
- 17 (3) circulating nomination petitions or nomination
- 18 papers;

- 1 (4) making telephone calls in an organized effort;
- 2 (5) organizing or promoting events;
- 3 (6) polling;
- 4 (7) poll watching; and
- 5 (8) typing, creating, copying, ordering, receiving or
- 6 distributing brochures, flyers, signs or political literature
- 7 of any kind.
- 8 "Public employee." Any person employed by a public employer.
- 9 This term shall not include a contractor or an annuitant.
- 10 "Public employer." The Commonwealth or its political
- 11 subdivisions, including school districts and any office,
- 12 department, authority, board, agency, multistate agency,
- 13 commission or other instrumentality which provides sick time for
- 14 public employees.
- 15 "Sick time." Leave from employment designated for a public
- 16 employee by a public employer for a time period when the public
- 17 employee becomes too ill to work or must be absent from work for
- 18 a valid sick-related reason, whether or not the public employee
- 19 is compensated. The term shall include leave taken under the
- 20 Federal Family and Medical Leave Act of 1993 (Public Law 103-3,
- 21 29 U.S.C. § 2601 et seq.).
- 22 Section 3. Prohibited use of sick time.
- 23 A public employee may not use sick time to engage in campaign
- 24 activities.
- 25 Section 4. Penalties.
- Any person who violates section 3 commits a misdemeanor of
- 27 the third degree and shall, upon conviction, be sentenced to pay
- 28 a fine of not more than \$1,000 or imprisonment for not more than
- 29 one year, or both.
- 30 Section 5. Effective date.

1 This act shall take effect in 60 days.
