BRIDGE; DESIGNATING THE BRIDGE LOCATED ON STATE ROUTE 34 THAT 1 CONNECTS THE BANKS OF THE JUNIATA RIVER IN NEWPORT, PERRY 2 COUNTY, AS THE PAUL REIDER BRIDGE; AND DESIGNATING A PORTION OF STATE ROUTE 2029 AND 2049, ALSO KNOWN AS BATH ROAD, IN 3 4 BRISTOL TOWNSHIP, BUCKS COUNTY, AS THE SERGEANT GEORGE 5 STUCKEY MEMORIAL ROAD; AND MAKING A RELATED REPEAL. 6 7 The General Assembly of the Commonwealth of Pennsylvania 8 hereby enacts as follows: Section 1. William J. Guarnere and Edward "Babe" Heffron 9 10 Memorial Boulevard. 11 (a) William J. Guarnere. -- The General Assembly finds and 12 declares as follows: 13 Born in South Philadelphia on April 28, 1923, (1)14 William J. Guarnere, also known as Wild Bill, was the son of the late Joseph and Augusta Guarnere. 15 16 Mr. Guarnere joined the Citizens Military Training (2) Camp and graduated from South Philadelphia High School in 17 18 1941 while working for Baldwin Locomotive Works building 19 Sherman tanks for the United States Army. 20 He enlisted in the United States Army on August 31, (3) 21 1942, and served as a Staff Sergeant with Easy Company, 2nd 22 Battalion, 506th Parachute Infantry Regiment, in the 101st 23 Airborne Division during World War II. 24 As a paratrooper, Mr. Guarnere made his first combat (4) 25 jump on D-Day as part of the Allied invasion of France, and 26 he fought during the Battle of Normandy, Operation Market 27 Garden and the Battle of the Bulge. He was awarded the Silver Star, the Bronze Star with 28 (5) 29 oak leaf cluster, the Purple Heart with two oak leaf 30 clusters, the Good Conduct Medal, the Campaign Medal with 31 three service stars and arrow device, the World War II Victory Medal and a Presidential Unit Citation with oak leaf 32 33 cluster.

4 (7) He was a beloved family member, dedicated worker and
5 honorable military veteran. He exemplified the best qualities
6 of the human experience.

7 (8) William J. Guarnere passed away at the age of 90 on
8 March 8, 2014. He generously gave his heart and time to
9 enhance the quality of life of his family and community.

10 (b) Mr. Edward "Babe" Heffron.--The General Assembly further 11 finds and declares as follows:

12 (1) Born in South Philadelphia on May 16, 1923, Edward
13 James Heffron, also known as Babe, was the son of the late
14 Joseph and Anne Heffron.

15 (2) Mr. Heffron attended Sacred Heart Catholic School16 and South Philadelphia High School.

17 (3) Mr. Heffron was employed with New York Shipbuilding
18 in Camden, New Jersey, before enlisting in the United States
19 Army on November 7, 1942.

(4) He served as a Private First Class with Easy
Company, 2nd Battalion, 506th Parachute Infantry Regiment, in
the 101st Airborne Division during World War II.

(5) Mr. Heffron fought in several battles, including
Operation Market Garden and the Battle of the Bulge, and was
involved in the liberation of the Kaufering concentration
camp in Landsberg, Germany.

27 (6) For his gallant service, Mr. Heffron received the
28 Bronze Star, Purple Heart, the Good Conduct Medal and the
29 European-African-Middle Eastern Campaign Medal.

30 (7) He was also portrayed in the miniseries, Band of

5 (1) LIEUTENANT COLONEL MICHAEL E. MCLAUGHLIN SERVED THIS 6 COUNTRY AND THIS COMMONWEALTH WITH HONOR AND DISTINCTION AS A 7 MEMBER OF THE PENNSYLVANIA NATIONAL GUARD. HE WAS A NATIVE OF 8 TIONESTA, FOREST COUNTY, AND WAS A PRIVATE CONTRACTOR IN 9 MERCER WHEN HE MOBILIZED WITH THE 2ND BRIGADE COMBAT TEAM, 10 28TH INFANTRY DIVISION, OF THE PENNSYLVANIA NATIONAL GUARD IN 11 2005.

12 (2) ON JANUARY 5, 2006, LIEUTENANT COLONEL MCLAUGHLIN 13 GAVE HIS LIFE IN THE LINE OF DUTY WHEN HE WAS KILLED IN 14 ACTION IN RAMADI, IRAQ. HE WAS THE FIRST OFFICER IN THE 15 PENNSYLVANIA NATIONAL GUARD TO BE KILLED IN ACTION SINCE 16 WORLD WAR II.

(B) DESIGNATION.--EXIT 113, STATE RAMP 8001, FROM INTERSTATE
79 ONTO STATE ROUTE 208, IN SPRINGFIELD TOWNSHIP, MERCER COUNTY,

3 (3) THOMAS R. MATTY ENLISTED IN THE UNITED STATES MARINE
4 CORPS IN 1966. HE ATTENDED BOOT CAMP TRAINING AT PARRIS
5 ISLAND AND ADDITIONAL TRAINING AT CAMP LEJEUNE AND AT EL
6 TORO, CALIFORNIA. HE ARRIVED IN VIETNAM ON NOVEMBER 9, 1967.

7 (4) MARINE CPL. THOMAS R. MATTY MADE THE ULTIMATE
8 SACRIFICE FOR HIS COUNTRY WHEN HE WAS KILLED IN THE VICINITY

5 (2) RICHARD W. KOWALEWSKI, JR., ENLISTED IN THE UNITED
6 STATES ARMY AND COMPLETED BASIC TRAINING IN JUNE 1992.

7 (3) SPECIALIST KOWALEWSKI WAS LATER ASSIGNED TO THE 3RD
8 BATTALION, 75TH RANGER REGIMENT.

9 (4) AS PART OF A UNITED NATIONS PEACEKEEPING OPERATION,
10 SPECIALIST KOWALEWSKI WAS DEPLOYED TO SOMALIA IN AUGUST 1993.

(5) ON OCTOBER 3, 1993, SPECIALIST KOWALEWSKI, ALONG
WITH 17 OTHER MEN, WAS KILLED IN THE BATTLE OF MOGADISHU.

4 RIVER CONNECTING NEWPORT TO HOWE TOWNSHIP.

5 (5) THAT BRIDGE WAS DESTROYED IN AN 1889 FLOOD AND

7 (6) IN 1903, THE COVERED BRIDGE WAS REPLACED WITH AN
8 IRON BRIDGE.

CHILD. HE WAS A GRADUATE OF DELHAAS HIGH SCHOOL.

26 (2) SERGEANT STUCKEY WAS A POLICE OFFICER WITH THE
27 BRISTOL TOWNSHIP POLICE DEPARTMENT WHERE HE SERVED FOR SEVEN
28 YEARS. HE HELD THE RANK OF DETECTIVE FOR FIVE YEARS BEFORE
29 BECOMING ACTING SERGEANT IN THE DETECTIVE DIVISION. HE SERVED
30 AS THE DEPARTMENT'S PHOTOGRAPHIC EXPERT.

1 (3) SERGEANT STUCKEY MADE THE ULTIMATE SACRIFICE ON 2 MARCH 29, 1972, WHEN HE WAS SHOT AND KILLED IN THE LINE OF 3 DUTY WHILE STOPPING A VEHICLE INVOLVED IN A BANK ROBBERY 4 ALONG BATH ROAD IN BRISTOL TOWNSHIP. THE SHOOTING OCCURRED 5 ONLY A COUPLE HUNDRED FEET FROM THE POLICE HEADQUARTERS.
