## AN ACT

- Amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in registration of vehicles, further providing for
- antique, classic and collectible plates.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 1340 heading, (a) and (b) of Title 75 of
- 7 the Pennsylvania Consolidated Statutes are amended to read:
- 8 § 1340. Antique, classic [and], collectible and antique
- 9 military plates.
- 10 (a) General rule. -- Upon submission by a vehicle owner of
- 11 information satisfactory to the department that a motorcycle or
- 12 motor vehicle is an antique motorcycle or motor vehicle or
- 13 classic motorcycle or motor vehicle or collectible motorcycle or
- 14 motor vehicle or antique military motorcycle or motor vehicle,
- 15 accompanied by the appropriate fee, the department may issue
- 16 special plates for the motorcycle or vehicle. The special plate
- 17 for antique motor vehicles, except antique motorcycles and

- 1 <u>antique military motorcycles or motor vehicles</u>, shall bear the
- 2 designation "antique vehicle." The special plate for antique
- 3 military motorcycles or motor vehicles shall be olive drab color
- 4 and bear the designation "antique military vehicle." The
- 5 applicant shall provide photographic proof in a manner specified
- 6 by the department to demonstrate the condition of the motor
- 7 vehicle. No annual registration fee may be charged for antique,
- 8 collectible or classic motorcycles or motor vehicles or antique
- 9 military motorcycles or motor vehicles. A holder of the special
- 10 plates may obtain replacement plates bearing the designation
- 11 "antique vehicle" or "antique military vehicle," as appropriate,
- 12 upon payment of the appropriate fee.

- 14 (b) Use of plates.--It is unlawful for any person to operate
- 15 a motorcycle or vehicle with antique, classic, vintage or
- 16 collectible or antique military registration plates for general
- 17 daily transportation. Permitted use shall be limited to
- 18 participation in club activities, exhibits, tours, parades,
- 19 occasional transportation and similar uses. Occasional
- 20 transportation shall mean no more than one day per week.
- 21 Section 2. This act shall take effect in 60 days.
