AN ACT

- 1 Amending Title 35 (Health and Safety) of the Pennsylvania
- 2 Consolidated Statutes, in emergency telephone service,
- providing for prohibited release of information.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Title 35 of the Pennsylvania Consolidated
- 7 Statutes is amended by adding a section to read:
- 8 § 5399. Prohibited release of information.
- 9 (a) Prohibition. -- Notwithstanding any other law, in a
- 10 response to a request under the act of February 14, 2008 (P.L.6,
- 11 No.3), known as the Right-to-Know Law, a PSAP may not release a <--
- 12 public record or part of a public record containing identifying
- 13 <u>information related to an individual calling a 911 center.</u>
- 14 INDIVIDUAL IDENTIFYING INFORMATION OF AN INDIVIDUAL CALLING A <--
- 15 911 CENTER, VICTIM OR WITNESS.
- 16 (B) APPLICABILITY.--THIS SECTION SHALL NOT APPLY IF THE PSAP

- 1 OR A COURT DETERMINES THAT THE PUBLIC INTEREST IN DISCLOSURE
- 2 OUTWEIGHS THE INTEREST IN NONDISCLOSURE.
- 3 (b) (C) Definition.--As used in this section, the term <--
- 4 "identifying information" includes name, telephone number, <--
- 5 <u>address and location.</u> AND HOME ADDRESS. THE TERM DOES NOT_
- 6 <u>INCLUDE</u>:
- 7 (1) THE LOCATION OF THE INCIDENT, UNLESS THE LOCATION IS
- 8 THE CALLER'S, VICTIM'S OR WITNESS'S HOME ADDRESS OR THE
- 9 DISCLOSURE OF THE LOCATION WOULD COMPROMISE THE IDENTITY OF
- 10 THE CALLER, VICTIM OR WITNESS.
- 11 (2) THE STREET BLOCK IDENTIFIER, THE CROSS STREET OR THE
- 12 MILE MARKER NEAREST THE SCENE OF THE INCIDENT, WHICH SHALL BE
- 13 PUBLIC.
- 14 Section 2. This act shall take effect in 60 days.
