AN ACT

Amending the act of June 13, 1967 (P.L.31, No.21), entitled "An act to consolidate, editorially revise, and codify the public 2 welfare laws of the Commonwealth," providing for family 3 conferencing. 4 5 The General Assembly of the Commonwealth of Pennsylvania 6 hereby enacts as follows: 7 Section 1. The act of June 13, 1967 (P.L.31, No.21), known as the Public Welfare Code, is amended by adding an article to 8 9 read: 10 ARTICLE XIII-B 11 FAMILY CONFERENCING 12 Section 1301-B. Scope of article. This article relates to family conferencing. 13 Section 1302-B. Definitions. 14 15 The following words and phrases when used in this article 16 shall have the meanings given to them in this section unless the context clearly indicates otherwise: 17 "Accept for service." Decide on the basis of the needs and 18 problems of an individual to admit or receive the individual as 19

- 1 <u>a client of the county agency or as required by a court order</u>
- 2 <u>entered under 42 Pa.C.S. Ch. 63 (relating to juvenile matters).</u>
- 3 "Child." As defined in section 1302.
- 4 <u>"Children and youth social services." Public child welfare</u>
- 5 <u>services</u>, including those activities or services designed to:
- 6 (1) Prevent neglect, abuse and exploitation and help
- 7 <u>overcome problems that result in dependency and delinquency.</u>
- 8 (2) Provide services which protect children from
- 9 continued harm to families in their own homes.
- 10 (3) Provide temporary, substitute care in foster family
- 11 <u>homes or residential child care facilities for a child in</u>
- 12 need of care.
- 13 <u>(4) Reunite children and their families if children are</u>
- 14 <u>placed in temporary substitute care.</u>
- 15 (5) Provide a permanent, legally assured family for
- children in temporary, substitute care who cannot be returned
- 17 to their homes.
- 18 (6) Provide court-ordered care or supervision to alleged
- or adjudicated dependent or delinquent children.
- 20 "County agency." As defined in section 1302.
- 21 "Family." A child's parents, stepparents, relatives and kin.
- 22 <u>"Family conferencing." A child welfare practice where a</u>
- 23 child's family, in consultation with a county agency or its
- 24 designee, develops a plan to address concerns for the child's
- 25 safety, permanency and well-being through meetings sponsored by
- 26 a county agency or its designee.
- 27 "Kin." As defined in section 1302.
- 28 "Relative." As defined in section 1302.
- 29 "Service plan." A written plan for a family receiving
- 30 children and youth social services that is developed in

- 1 accordance with department regulations.
- 2 Section 1303-B. Offer of family conferencing.
- 3 (a) General rule. -- Within five years of the effective date
- 4 of this article, a county agency shall offer all children and
- 5 <u>families who are accepted for service an opportunity to engage</u>
- 6 in family conferencing. Family conferencing shall be offered at
- 7 key decision points that impact the development or revision of
- 8 service plans for the child and the family. Family conferencing
- 9 shall be offered until the child and the family's involvement
- 10 with the county agency is terminated.
- 11 (b) Exceptions. -- The county agency is not required to offer
- 12 family conferencing in the following situations:
- 13 (1) The child has been adjudicated dependent under 42
- Pa.C.S. Ch. 63 (relating to juvenile matters) and the court
- 15 <u>has made a specific determination that family conferencing is</u>
- 16 <u>not best suited to the safety, protection and physical,</u>
- 17 mental and moral welfare of the child or is a threat to the
- 18 safety of the child or another family member.
- 19 (2) The child is not under the jurisdiction of the court
- and the county agency has determined that continued family
- 21 conferencing is a threat to the safety of the child or
- 22 another family member. A determination that continued family
- 23 conferencing is a threat to the safety of the child or
- another family member must be based on credible information
- about a specific safety threat, and the county agency shall
- document the reasons for its determination.
- 27 (3) The child is in a preadoptive placement, and court
- 28 proceedings to adopt the child have been commenced under 23
- 29 Pa.C.S. Pt. III (relating to adoption).
- 30 Section 1304-B. Preparing for the family conference.

| 1 | The county agency's responsibilities when preparing for the |

| 2 | family conference shall include, but are not limited to: |
| 3 | (1) Consulting with the child and the child's parents or |
| 4 | legal guardian to determine who the parents or legal guardian |
| 5 | wants to invite to attend the family conference. |
| 6 | (2) Allowing the child and the child's siblings to |
| 7 | participate in the family conference in a manner appropriate |
| 8 | to age and maturity. |
| 9 | (3) Preparing the family and child to safely participate |
| 10 | in the family conference. This preparation includes, but is |
| 11 | <pre>not limited to:</pre> |
| 12 | (i) Identifying services available to assist the |
| 13 | family with addressing concerns identified by the county |
| 14 | agency or the court. |
| 15 | (ii) Informing the family about the purpose and the |
| 16 | goal of the family conference and the identified services |
| 17 | available to assist them with addressing the concerns for |
| 18 | the child. |
| 19 | (4) Equally promoting maternal and paternal family |
| 20 | involvement in the family conference. |
| 21 | (5) Consulting relevant service providers. |
| 22 | (6) Consulting and engaging the child's guardian ad |
| 23 | litem and the parent's attorney, if applicable. |
| 24 | Section 1305-B. Family responsibilities. |
| 25 | The family shall be responsible for the development of a |
| 26 | plan, which shall be incorporated into the service plan. The |
| 27 | plan shall address the concerns of safety, permanency and well- |
| 28 | being within the family as well as other concerns which have |
| 2 0 | been identified by the gounty agency or the gourt regarding the |

- 1 Section 1306-B. Family discussion.
- 2 The family conference shall include a discussion by the
- 3 family about the available resources within the family, the
- 4 community and the county agency. The family shall be responsible
- 5 for determining which resources to utilize to address the
- 6 concerns of safety, permanency and well-being identified by the
- 7 county agency or the court. The family shall determine whether
- 8 or not to hold this discussion in private. However, if the child
- 9 <u>is under the jurisdiction of the court, the court may require</u>
- 10 that the discussion be held in private by the family.
- 11 <u>Section 1307-B. Plan requirements.</u>
- In order for a plan to take effect, it must be approved by
- 13 the county agency. If the child is under the jurisdiction of the
- 14 court, the plan must be submitted to the court for approval. If
- 15 <u>a family is unable to develop an approved plan through the</u>
- 16 <u>family conference</u>, the county agency shall determine other means
- 17 to engage the family and the child, if appropriate, in the
- 18 development of a plan that addresses the concerns of safety,
- 19 permanency and well-being identified by the county agency or the
- 20 court. The county agency shall support the implementation of the
- 21 plan and attempt to ensure that the implementation of the plan
- 22 resolves the safety, permanency and well-being concerns
- 23 identified by the county agency or the court. Reasonable efforts
- 24 to engage the child's family in decisions regarding the child's
- 25 safety, permanency or well-being shall be made by the county
- 26 agency on an ongoing basis until the child's involvement with
- 27 the county agency is terminated.
- 28 Section 1308-B. Implementation of family conferencing.
- 29 The department shall require county agencies to gradually
- 30 implement family conferencing so that county agencies are

- 1 prepared to comply with this article as follows:
- 2 (1) Within three years of the effective date of this
- 3 article, a county agency shall offer an opportunity to engage
- 4 <u>in family conferencing to all children and families where the</u>
- 5 <u>child has been placed outside the home.</u>
- 6 (2) Within five years of the effective date of this
- 7 article, a county agency shall offer an opportunity to engage
- 8 in family conferencing to all children and families who are
- 9 <u>accepted for service.</u>
- 10 Section 1309-B. Regulations.
- 11 Within one year of the effective date of this article, the
- 12 department shall promulgate regulations necessary to carry out
- 13 the provisions of this article.
- 14 Section 2. This act shall take effect in 60 days.
