## AN ACT

- Establishing the LGBT Senior Community Grant Program; conferring powers and imposing duties on the Department of Aging; and making an appropriation.

- 1 Section 1. Short title.
- 2 This act shall be known and may be cited as the Lesbian, Gay,
- 3 Bisexual and Transgender (LGBT) Senior Community Grant Program
- 4 Act.
- 5 Section 2. Declaration of policy.
- 6 (a) Purpose of program. -- The purpose of the LGBT Senior
- 7 Community Grant Program is to facilitate the social, emotional
- 8 and physical well-being of lesbian, gay, bisexual and
- 9 transgender seniors in this Commonwealth by the establishment
- 10 of, and support for, community-based services, programs and
- 11 activities that support LGBT seniors and the LGBT community.
- 12 (b) Use of grants. -- By establishment of the LGBT Senior
- 13 Community Grant Program, the General Assembly intends that
- 14 grants provided under this act be used to support a not-for-
- 15 profit organization, county government or municipal government
- 16 for community-based services, programs and activities conducive
- 17 to the achievement of these goals as well as other purposes.
- 18 Section 3. Definitions.
- 19 The following words and phrases when used in this act shall
- 20 have the meanings given to them in this section unless the
- 21 context clearly indicates otherwise:
- 22 "Department." The Department of Aging of the Commonwealth.
- 23 "Program." The LGBT Senior Community Grant Program
- 24 established under this act.
- 25 Section 4. Establishment.
- There is established in the department a program to be known
- 27 as the LGBT Senior Community Grant Program. The purpose of the
- 28 program shall be to provide annual grants to eligible not-for-
- 29 profit organizations, county governments or municipal
- 30 governments for community-based services, programs and

- 1 activities that support LGBT seniors and the LGBT community.
- 2 Section 5. Applications.
- 3 (a) Development and availability. -- Grant application forms
- 4 shall be developed by the department and be made available on
- 5 the department's publicly accessible Internet website.
- 6 (b) Compliance. -- The department shall verify in writing on
- 7 each grant application that the application complies with all
- 8 the requirements under section 6.
- 9 Section 6. Requirements.
- 10 Grants shall be awarded by the department to eligible not-
- 11 for-profit organizations, county governments or municipal
- 12 governments which have been approved by the department. Grants
- 13 shall be given for any and all of the following purposes:
- 14 (1) Health care services for LGBT seniors.
- 15 (2) Cultural competency training for health care
- 16 providers, social service providers and other members of the
- 17 community to include discussion of issues related to LGBT
- 18 seniors.
- 19 (3) Social activities and outreach programs for LGBT
- seniors.
- 21 (4) Computer and job training for LGBT seniors.
- 22 (5) Any other related services that support LGBT seniors
- and the LGBT community, or have a sizeable number of LGBT
- seniors as members.
- 25 Section 7. Restriction.
- 26 The LGBT Senior Community Grant may not be used for the
- 27 capital needs of a not-for-profit organization, county
- 28 government or municipal government.
- 29 Section 8. Powers and duties of department.
- 30 The powers and duties of the department shall be:

- 1 (1) To accept grants from the Federal Government and any
- 2 other government or individual or agency for use in the
- 3 program.
- 4 (2) To promulgate rules, regulations and directives the
- 5 department deems necessary to carry out the provisions of
- 6 this act.
- 7 Section 9. Awarding of grants.
- 8 (a) General rule. -- The department shall award grants to
- 9 eligible not-for-profit organizations, county governments or
- 10 municipal governments which have been approved by the department
- 11 for the purposes of this act.
- 12 (b) Amount.--Grant amounts may not exceed a maximum of
- 13 \$50,000 for each not-for-profit organization, county government
- 14 or municipal government approved under this act.
- 15 Section 10. Funding.
- 16 (a) General rule. -- Notwithstanding sections 301, 303 and 311
- 17 of the act of August 26, 1971 (P.L.351, No.91), known as the
- 18 State Lottery Law, funding for the program shall be an eligible
- 19 use for money in the State Lottery Fund.
- 20 (b) Appropriation. -- For fiscal year 2015-2016, and each
- 21 fiscal year thereafter, the sum of \$500,000 shall be
- 22 appropriated from the State Lottery Fund to the department for
- 23 the LGBT Senior Community Grant Program.
- 24 Section 11. Effective date.
- This act shall take effect in 60 days.
