AN ACT

Amending Titles 51 (Military Affairs) and 74 (Transportation) of the Pennsylvania Consolidated Statutes, in veteran-owned small businesses, further providing for definitions, for 3 regulations, for participation goal, for duties of Department of General Services, for bonding and progress payments and 4 5 for reports; providing for business fee exemption; making 6 editorial changes; in administrative practice and procedure, 7 8 further providing for diverse business participation; and providing for the status of a veteran-owned small business 9 and a service-disabled veteran-owned small business. 10 11 The General Assembly of the Commonwealth of Pennsylvania 12 hereby enacts as follows: 13 Section 1. Chapter 96 of Title 51 of the Pennsylvania 14 Consolidated Statutes is amended by adding a subchapter heading 15 to read: 16 SUBCHAPTER A 17 PRELIMINARY PROVISIONS 18 Section 2. Section 9601 of Title 51 is amended to read: § 9601. Definitions. 19 Subject to section 9602 (relating to regulations), the 20

- 1 following words and phrases when used in this chapter shall have
- 2 the meanings given to them in this section unless the context
- 3 clearly indicates otherwise:
- 4 "Commonwealth agency." As defined in 62 Pa.C.S. § 103
- 5 (relating to definitions).
- 6 "Executive agency." As defined in 62 Pa.C.S. § 103 (relating
- 7 to definitions).
- 8 "Purchasing agency." As defined in 62 Pa.C.S. § 103
- 9 (relating to definitions).
- 10 ["Service-disabled." Being in possession of:
- 11 (1) a disability rating letter issued by the United
- 12 States Department of Veterans Affairs; or
- 13 (2) a disability determination from the United States
- 14 Department of Defense.
- "Service-disabled veteran-owned small business." A small
- 16 business owned and controlled by:
- 17 (1) a service-disabled veteran or veterans; or
- 18 (2) if approved by the Department of General Services, a
- 19 surviving spouse or permanent caregiver of a service-disabled
- veteran.
- 21 "Small business." As defined in 62 Pa.C.S. § 2102 (relating
- 22 to definitions).
- "State-affiliated entity." As defined in 62 Pa.C.S. § 103
- 24 (relating to definitions).
- 25 "Veteran." [An individual who served on active duty in the
- 26 United States Armed Forces, including any of the following:
- 27 (1) A reservist or member of the National Guard who was
- discharged or released from the service under honorable
- 29 conditions.
- 30 (2) A reservist or member of the National Guard who

- 1 completed an initial term of enlistment or qualifying period
- 2 of service.
- 3 (3) A reservist or member of the National Guard who was
- 4 disabled in the line of duty during training.] An individual
- 5 who served in the United States Armed Forces, including a
- 6 reserve component or the National Guard, and who was
- 7 <u>discharged or released from service under conditions other</u>
- 8 than dishonorable.
- 9 "Veteran-owned small business." A small business owned and
- 10 controlled by a veteran or veterans.
- 11 Section 3. Chapter 96 of Title 51 is amended by adding a
- 12 subchapter heading to read:

- 14 PARTICIPATION
- 15 Section 4. Sections 9602, 9603, 9604, 9605 and 9607 of Title
- 16 51 are amended to read:
- 17 § 9602. Regulations.
- 18 (a) Promulgation. -- The Department of General Services shall
- 19 establish policy in accordance with this [chapter] <u>subchapter</u>
- 20 for executive agencies and independent agencies and may, in
- 21 consultation with the department, promulgate regulations
- 22 establishing detailed definitions of the words and phrases
- 23 defined in section 9601 (relating to definitions) using, in
- 24 addition to the criteria set forth in section 9601, other
- 25 criteria as it deems appropriate, including the number of
- 26 employees and the dollar volume of business.
- 27 (b) Implementation. -- State-affiliated entities shall
- 28 implement the policy for their procurement programs.
- 29 (c) Antifraud provisions. -- The Department of General
- 30 Services shall establish policy and promulgate regulations

- 1 establishing antifraud provisions to deter and penalize
- 2 businesses that are not owned by [those who are service-disabled
- 3 or by] veterans but who falsely claim that they are in order to
- 4 receive any action authorized by this [chapter] subchapter.
- 5 (d) Notice. -- Notice of the antifraud provisions and an
- 6 e-mail address and telephone number to report violations of the
- 7 antifraud provisions to the Department of General Services shall
- 8 be included, if feasible, in any application to be certified or
- 9 to be included in any source list authorized by this [chapter]
- 10 <u>subchapter</u>. The Department of General Services shall include in
- 11 its annual reports to the General Assembly information about the
- 12 number of businesses penalized for violating antifraud
- 13 provisions.
- 14 § 9603. Participation goal.
- A Statewide annual goal of not less than 3% participation by
- 16 veteran-owned small businesses[, including service-disabled
- 17 veteran-owned small businesses,] is established. The
- 18 participation goal shall apply to the total value of all
- 19 contracts available to small businesses in each fiscal year.
- 20 § 9604. Duties of Department of General Services.
- 21 The Department of General Services, with the assistance of
- 22 the department, shall have the following duties:
- 23 (1) If feasible, provide appropriate staff, who shall be
- 24 responsible to the Department of General Services and who
- shall serve within designated Commonwealth agencies to assist
- veteran-owned small businesses [and service-disabled veteran-
- owned small businesses] in this Commonwealth in learning how
- to do business with Commonwealth agencies.
- 29 (2) Give special publicity to procurement procedures and
- 30 issue special publications designed to assist veteran-owned

- 1 small businesses [and service-disabled veteran-owned small
- 2 businesses] in learning how to do business with Commonwealth
- 3 agencies.
- 4 (3) Compile, maintain and make available source lists of
- 5 veteran-owned small businesses [and service-disabled veteran-
- 6 owned small businesses] for the purpose of encouraging
- 7 procurement from veteran-owned small businesses.
- 8 (4) Include veteran-owned small businesses [and service-
- 9 disabled veteran-owned small businesses] on solicitation
- 10 mailing lists.
- 11 (5) Assure that veteran-owned small businesses [and
- service-disabled veteran-owned small businesses] are
- solicited on procurements for which the businesses may be
- 14 suited.
- 15 (6) Develop special training programs to assist veteran-
- owned small businesses [and service-disabled veteran-owned]
- 17 small businesses] in learning how to do business with
- 18 Commonwealth agencies.
- 19 (7) Assure that participation by veteran-owned small
- 20 businesses [and service-disabled veteran-owned small
- 21 businesses] is, if appropriate, factored into the evaluation
- 22 of proposals for supplies, services or construction when a
- 23 purchasing agency uses the competitive sealed proposals
- 24 method under 62 Pa.C.S. § 513 (relating to competitive sealed
- 25 proposals).
- 26 (8) Verify the current certification of businesses
- 27 claiming to be certified as veteran-owned small businesses
- [and service-disabled veteran-owned small businesses].
- 29 § 9605. Bonding and progress payments.
- 30 (a) Bonding.--Notwithstanding 62 Pa.C.S. Pt. I (relating to

- 1 Commonwealth Procurement Code):
- 2 (1) Except as provided in paragraph (2), a purchasing
- 3 agency may reduce the level or change the types of bonding
- 4 normally required or accept alternative forms of security to
- 5 the extent reasonably necessary to encourage procurement from
- 6 veteran-owned small businesses [and service-disabled veteran-
- 7 owned small businesses].
- 8 (2) For contracts under \$25,000, veteran-owned small
- 9 businesses [and service-disabled veteran-owned small
- 10 businesses] shall be exempt from any bonding requirements.
- 11 (b) Progress payments. -- A purchasing agency may make special
- 12 provisions for progress payments as it deems reasonably
- 13 necessary to encourage procurement from veteran-owned small
- 14 businesses [and service-disabled veteran-owned small
- 15 businesses].
- 16 § 9607. Reports.
- 17 (a) Report to Department of General Services. -- By August 15,
- 18 2013, and each August 15 thereafter, each executive agency and
- 19 independent agency shall submit an annual report for the period
- 20 of July 1 to June 30 to the Department of General Services on
- 21 actual utilization of veteran-owned small businesses [and
- 22 service-disabled veteran-owned small businesses] as contractors,
- 23 subcontractors, suppliers and professional service providers.
- 24 (b) Report to standing committees.--
- 25 (1) The Department of General Services and each State-
- affiliated entity shall annually, before October 1, report in
- 27 writing to the Veterans Affairs and Emergency Preparedness
- 28 Committee of the Senate and the Veterans Affairs and
- 29 Emergency Preparedness Committee of the House of
- Representatives the actual utilization, Statewide and by each

- 1 purchasing agency, of veteran-owned small businesses [and
- 2 service-disabled veteran-owned small businesses] during the
- 3 preceding fiscal year.
- 4 (2) The report shall include a list of all veteran-owned
- 5 small businesses [and service-disabled veteran-owned small
- 6 businesses] that participated as contractors, subcontractors,
- 7 suppliers and professional service providers during the
- 8 preceding fiscal year.
- 9 (3) Initial reports under this subsection shall be
- submitted to the standing committees by October 1, 2013.

- 17 <u>9611. Exemption.</u>
- 18 § 9610. Definitions.
- 19 As used in this subchapter, the following words and phrases
- 20 shall have the meanings given to them in this section unless the
- 21 context clearly indicates otherwise:
- 22 "Business fee." A fee required to be paid to the
- 23 Commonwealth or an instrumentality of the Commonwealth for
- 24 starting or opening a business within this Commonwealth.
- 25 § 9611. Exemption.
- 26 (a) Payment.--A veteran-owned small business shall be exempt
- 27 <u>from the payment of a business fee.</u>
- 28 (b) Proof. -- A veteran must provide the department with proof
- 29 of the veteran's status using any of the following:
- 30 (1) A copy of a Federal DD-214 form.

- 1 (2) A copy of a Federal NGB-22 form.
- 2 (3) A valid Federal Veterans' Administration card.
- 3 (4) An identification card issued under 75 Pa.C.S. §
- 4 <u>1510(a.1) (relating to issuance and content of driver's</u>
- 5 license).
- 6 (c) Status. -- The Department of State, in consultation with
- 7 the department, shall determine an applicant's status as a
- 8 <u>veteran in accordance with this section.</u>
- 9 (d) Offenses.--
- 10 (1) A person who fraudulently obtains a business fee
- 11 <u>exemption commits a misdemeanor of the third degree.</u>
- 12 (2) A person assigning, transferring or attempting to
- 13 <u>assign or transfer a business fee exemption or using or</u>
- 14 <u>attempting to use a business fee exemption contrary to this</u>
- 15 <u>section commits a misdemeanor of the third degree.</u>
- 16 (e) Reporting. -- The Department of State shall annually
- 17 determine the total number of business fee exemptions issued
- 18 under this section.
- 19 Section 6. The definitions of "diverse business" and
- 20 "service-disabled veteran-owned small business" in section
- 21 303(b) of Title 74 are amended to read:
- 22 § 303. Diverse business participation.
- 23 * * *
- 24 (b) Definitions.--As used in this section, the following
- 25 words and phrases shall have the meanings given to them in this
- 26 subsection:
- 27 * * *
- 28 "Diverse business." A disadvantaged business, minority-owned
- 29 or women-owned business [or service-disabled veteran-owned] or
- 30 veteran-owned small business that has been certified by a third-

- 1 party certifying organization.
- 2 * * *
- 3 ["Service-disabled veteran-owned small business." As defined
- 4 in 51 Pa.C.S. § 9601 (relating to definitions).]
- 5 * * *
- 6 Section 7. The amendment of 51 Pa.C.S. §§ 9601, 9602, 9603,
- 7 9604, 9605 and 9607 and the definitions of "diverse business"
- 8 and "service-disabled veteran-owned small business" in 74
- 9 Pa.C.S. § 303(b) shall not affect nor impair the status of any
- 10 of the following under 51 Pa.C.S. Ch. 96 or 74 Pa.C.S.:
- 11 (1) A veteran-owned small business.
- 12 (2) A service-disabled veteran-owned small business.
- 13 Section 8. This act shall take effect in 60 days.
