AN ACT

- 1 Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An
- act relating to the public school system, including certain
- provisions applicable as well to private and parochial
- schools; amending, revising, consolidating and changing the
- laws relating thereto," in preliminary provisions, further
- 6 providing for Keystone Exams.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. Section 121 of the act of March 10, 1949 (P.L.30,
- 10 No.14), known as the Public School Code of 1949, added June 30,
- 11 2012 (P.L.684, No.82), is amended to read:
- 12 Section 121. Keystone Exams. -- (a) Subject to annual
- 13 appropriation, not later than the 2020-2021 school year, the
- 14 Department of Education shall develop and implement Keystone
- 15 Exams in the following subjects: algebra I, literature, biology,
- 16 English composition, algebra II, geometry, United States
- 17 history, chemistry, civics and government and world history. The
- 18 State Board of Education shall promulgate regulations, subject
- 19 to the act of June 25, 1982 (P.L.633, No.181), known as the

- 1 "Regulatory Review Act," necessary to implement this [section]
- 2 <u>subsection</u>.
- 3 (b) Notwithstanding any other provision of law to the
- 4 contrary, no child may be required to take a Keystone Exam if
- 5 the parent or quardian of the child notifies in writing the
- 6 <u>superintendent or chief administrator that the parent or</u>
- 7 guardian wishes for the child not to take the Keystone Exam.
- 8 (c) No student may be penalized by a school district, the
- 9 State Board of Education or the Commonwealth for failing to take
- 10 <u>a Keystone Exam if the parent or quardian of the child has</u>
- 11 provided notice under subsection (b).
- 12 (d) No student may be required to take a Keystone Exam as a
- 13 condition for high school graduation.
- 14 Section 2. This act shall take effect in 60 days.
