14 (1) POLICE DEPARTMENTS SHALL, UPON REQUEST, FURNISH A <--
15 CERTIFIED COPY OF THE FULL REPORT OF THE POLICE INVESTIGATION
16 OF ANY VEHICLE ACCIDENT TO ANY PERSON INVOLVED IN THE
17 ACCIDENT, HIS ATTORNEY OR INSURER, AND TO THE FEDERAL

1 GOVERNMENT, BRANCHES OF THE MILITARY SERVICE, COMMONWEALTH  
2 AGENCIES, AND TO OFFICIALS OF POLITICAL SUBDIVISIONS AND TO  
3 AGENCIES OF OTHER STATES AND NATIONS AND THEIR POLITICAL  
4 SUBDIVISIONS. IF THE REQUEST IS MADE WITHIN 15 DAYS OF THE  
5 ACCIDENT, THE POLICE DEPARTMENT SHALL FURNISH AN INITIAL  
6 WRITTEN REPORT OF THE ACCIDENT AT THE SAME TIME THE REPORT IS  
7 DELIVERED TO THE DEPARTMENT. IF THE INITIAL REPORT IS NOT  
8 COMPLETE, A SUPPLEMENTAL REPORT SHALL BE SUBMITTED AT A LATER  
9 DATE.

10 (2) Except as provided in paragraph (3), the cost of  
11 furnishing a copy of a report under this subsection shall not  
12 exceed [~~\$15~~] \$22.
