## AN ACT

Amending the act of April 9, 1929 (P.L.177, No.175), entitled 1 "An act providing for and reorganizing the conduct of the executive and administrative work of the Commonwealth by the 3 Executive Department thereof and the administrative departments, boards, commissions, and officers thereof, including the boards of trustees of State Normal Schools, or 5 6 Teachers Colleges; abolishing, creating, reorganizing or 7 8 authorizing the reorganization of certain administrative departments, boards, and commissions; defining the powers and 9 duties of the Governor and other executive and administrative 10 officers, and of the several administrative departments, 11 boards, commissions, and officers; fixing the salaries of the 12 Governor, Lieutenant Governor, and certain other executive 13 and administrative officers; providing for the appointment of 14 certain administrative officers, and of all deputies and 15 other assistants and employes in certain departments, boards, 16 and commissions; and prescribing the manner in which the 17 number and compensation of the deputies and all other 18 assistants and employes of certain departments, boards and 19 commissions shall be determined," further providing for the 20 21 fair share fee for employees of public employers. - 24 Section 1. The definitions of "public employer" and "school
- entity" in section 2215(a) of the act of April 9, 1929 (P.L.177, 25
- 26 No.175), known as The Administrative Code of 1929, added July

- 1 13, 1988 (P.L.493, No.84), are amended to read:
- 2 Section 2215. Fair Share Fee; Payroll Deduction.--(a) As
- 3 used in this section, the following words and phrases shall have
- 4 the meanings given to them in this subsection:

- 6 "Public employer" shall mean the Commonwealth of
- 7 Pennsylvania. [or a school entity.
- 8 "School entity" shall mean any school district, intermediate
- 9 unit or vocational-technical school.]

- 11 Section 2. No collective bargaining agreement made by a
- 12 school district, intermediate unit or vocational-technical
- 13 school after the effective date of this section nor any
- 14 extension of an existing collective bargaining agreement made by
- 15 a school district, intermediate unit or vocational-technical
- 16 school after the effective date of this section may require
- 17 payment of a fair share fee to the exclusive representative by a
- 18 nonmember of the exclusive representative.
- 19 Section 3. This act shall take effect immediately.
