AN ACT

- 1 Relieving certain employee organizations of certain duties and obligations; and making a related repeal.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the Collective
- 7 Bargaining Agreement Limitation Act.
- 8 Section 2. Limitation on collective bargaining agreements.
- 9 (a) General rule. -- No collective bargaining agreement made
- 10 after the effective date of this section by any political
- 11 subdivision nor any extension of an existing collective
- 12 bargaining agreement made after the effective date of this
- 13 section by any political subdivision may require payment of a
- 14 fair share fee to the exclusive representative by a nonmember of
- 15 the exclusive representative.
- 16 (b) Definition. -- As used in this section, the following
- 17 words and phrases shall have the meanings given to them in this

- 1 subsection unless the context clearly indicates otherwise:
- 2 "Exclusive representative." The employee organization
- 3 selected by the employees of a public employer to represent them
- 4 for purposes of collective bargaining pursuant to the act of
- 5 July 23, 1970 (P.L.563, No.195), known as the Public Employe
- 6 Relations Act.
- 7 "Fair share fee." The regular membership dues required of
- 8 members of the exclusive representative, less the cost for the
- 9 previous fiscal year of its activities or undertakings which
- 10 were not reasonably employed to implement or effectuate the
- 11 duties of the employee organization as exclusive representative.
- "Political subdivision." A county, city, borough,
- 13 incorporated town, township and county institution district.
- 14 Section 3. Repeals.
- 15 Repeals are as follows:
- 16 (1) The General Assembly declares that the repeal under
- paragraph (2) is necessary to effectuate this act.
- 18 (2) The act of June 2, 1993 (P.L.45, No.15), known as
- 19 the Public Employee Fair Share Fee Law, is repealed.
- 20 Section 4. Effective date.
- 21 This act shall take effect immediately.
