12	Section 1. The act of October 27, 2014 (P.L.2911, No.191),	<

16	Section 15. Licensing Boards to Require Addiction Education.	
17	(a) General rule. Each licensing board in the Department of	=
18	State jurisdiction over professional licensees who are	
19	dispensers or prescribers shall require:	
20	(1) Individuals applying for an initial license or	

1	certification issued by the licensing board, which license or
2	certification authorizes the licensee to be a dispenser or
3	prescriber, shall submit documentation acceptable to the
4	licensing board of the completion of at least three hours of
5	addiction education. The addiction education may occur as
6	part of the applicants' professional degree educational

8	(2) Dispensers and prescribers applying for the renewal
9	of a license or certification issued by the licensing board
10	to complete at least two hours of addiction education as a
11	portion of the total continuing education required for
12	biennial renewal.
13	(b) Consultation with department. Each licensing board
14	shall, in consultation with the department, approve the
15	curricula for the addiction education.
16	Section 2. This act shall take effect in 60 days.

21	SECTION 9.1. LICENSING BOARDS TO REQUIRE EDUCATION IN PAIN

24	(A) GENERAL RULE EXCEPT AS OTHERWISE PROVIDED FOR IN
25	SUBSECTION (C), EACH LICENSING BOARD IN THE DEPARTMENT OF STATE
26	WITH JURISDICTION OVER PROFESSIONAL LICENSEES WHO ARE DISPENSERS
27	OR PRESCRIBERS SHALL REQUIRE:
28	(1) INDIVIDUALS APPLYING FOR AN INITIAL LICENSE OR
29	CERTIFICATION ISSUED BY THE LICENSING BOARD, WHICH LICENSE OR
30	CERTIFICATION AUTHORIZES THE LICENSEE TO BE A DISPENSER OR

- 1 PRESCRIBER, TO SUBMIT, NO LATER THAN 12 MONTHS AFTER
- 2 OBTAINING AN INITIAL LICENSE OR CERTIFICATION, DOCUMENTATION
- 3 ACCEPTABLE TO THE LICENSING BOARD OF THE COMPLETION OF AT
- 4 LEAST TWO HOURS OF EDUCATION IN PAIN MANAGEMENT OR
- 5 IDENTIFICATION OF ADDICTION AND AT LEAST TWO HOURS OF
- 6 EDUCATION IN THE PRACTICES OF PRESCRIBING OR DISPENSING OF
- 7 OPIOIDS. THE EDUCATION MAY OCCUR AS PART OF THE APPLICANTS'
- 8 <u>PROFESSIONAL DEGREE EDUCATIONAL PROGRAM.</u>
- 9 (2) DISPENSERS AND PRESCRIBERS APPLYING FOR THE RENEWAL
- 10 OF A LICENSE OR CERTIFICATION ISSUED BY THE LICENSING BOARD
- 11 TO COMPLETE AT LEAST TWO HOURS OF EDUCATION IN PAIN
- 12 MANAGEMENT, IDENTIFICATION OF ADDICTION OR THE PRACTICES OF
- 13 PRESCRIBING OR DISPENSING OF OPIOIDS AS A PORTION OF THE
- 14 TOTAL CONTINUING EDUCATION REQUIRED FOR BIENNIAL RENEWAL.
- 15 (B) CONSULTATION WITH DEPARTMENT. -- EACH LICENSING BOARD
- 16 SHALL, IN CONSULTATION WITH THE DEPARTMENT, APPROVE THE
- 17 CURRICULA FOR THE PAIN MANAGEMENT, IDENTIFICATION OF ADDICTION
- 18 AND THE PRACTICES OF PRESCRIBING AND DISPENSING OF OPIOIDS
- 19 EDUCATION.
- 20 (C) EXCEPTION. -- THE REQUIREMENT IN SUBSECTION (A) (2) SHALL
- 21 NOT APPLY TO A DISPENSER OR PRESCRIBER WHO IS EXEMPT FROM THE
- 22 DRUG ENFORCEMENT ADMINISTRATION'S REQUIREMENTS FOR A
- 23 REGISTRATION NUMBER UNDER 21 CFR CH. II (RELATING TO DRUG
- 24 ENFORCEMENT ADMINISTRATION, DEPARTMENT OF JUSTICE) AND
- 25 APPLICABLE STATE LAW.
- 26 SECTION 2. THIS ACT SHALL TAKE EFFECT IN 60 DAYS.
