## A JOINT RESOLUTION

Proposing an amendment to the Constitution of the Commonwealth of Pennsylvania, in taxation and finance, further providing for exemptions and special provisions. 3 The General Assembly of the Commonwealth of Pennsylvania 4 hereby resolves as follows: 6 Section 1. The following amendment to the Constitution of 7 Pennsylvania is proposed in accordance with Article XI: 8 That section 2(b) of Article VIII be amended by adding a paragraph to read: 10 § 2. Exemptions and special provisions. 11 \* \* \* 12 (b) The General Assembly may, by law: \* \* \* 13 14 (vii) Permit the City of Philadelphia A CITY OF THE FIRST <--15 CLASS to impose taxes for the benefit of the City of 16 Philadelphia CITY OF THE FIRST CLASS on real estate used for <--

business purposes at a tax rate that exceeds the tax rate

- 3 (A) So long as a rate variance is in effect, the rate
- 4 applicable to other real estate may not vary by more than
- 5 fifteen percent from the rate applicable to real estate used for

- 8 Philadelphia CITY OF THE FIRST CLASS to reduce the aggregate <--
- 9 revenue from other taxes imposed for the benefit of the City of

- 19 required advertisements to two newspapers in every county in
- 20 which such newspapers are published in sufficient time after
- 21 passage of this proposed constitutional amendment.
- 22 (b) Upon the second passage by the General Assembly of this
- 23 proposed constitutional amendment, the Secretary of the
- 24 Commonwealth shall proceed immediately to comply with the
- 25 advertising requirements of section 1 of Article XI of the
- 26 Constitution of Pennsylvania and shall transmit the required
- 27 advertisements to two newspapers in every county in which such
- 28 newspapers are published in sufficient time after passage of
- 29 this proposed constitutional amendment. The Secretary of the
- 30 Commonwealth shall submit this proposed constitutional amendment

- 1 to the qualified electors of this Commonwealth at the first
- 2 primary, general or municipal election which meets the
- 3 requirements of and is in conformance with section 1 of Article
- 4 XI of the Constitution of Pennsylvania and which occurs at least
- 5 three months after the proposed constitutional amendment is
- 6 passed by the General Assembly.
