AN ACT

- 1 Authorizing the Department of General Services, with the
- approval of the Department of Transportation and the
- Governor, to grant and convey, at a price to be determined
- 4 through a competitive bid process, certain lands, buildings
- and improvements situate in Lawrence Township, Clearfield
- 6 County.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. Conveyance authorization and competitive bidding.
- 10 The Department of General Services, with the approval of the
- 11 Department of Transportation and the Governor, is hereby
- 12 authorized on behalf of the Commonwealth of Pennsylvania to
- 13 grant and convey, at a price to be determined through a
- 14 competitive bidding process, the following tract of land
- 15 together with any buildings, structures or improvements thereon,
- 16 situate in Lawrence Township, Clearfield County.
- 17 Section 2. Property description.
- 18 The property to be conveyed under section 1 consists of a
- 19 tract of land totaling approximately 4.27 acres, including any
- 20 and all improvements located thereon, more particularly

- 1 described as follows:
- 2 ALL THAT CERTAIN piece or parcel of land located in Lawrence
- 3 Township, Clearfield County, Pennsylvania, bounded and described
- 4 as follows:
- 5 BEGINNING at a point offset northeasterly, at 90 degrees to
- 6 and 30 feet from the center line of State Highway Route 57, at
- 7 Station 1018/98.10, of the State Highway Straight Line Diagram
- 8 Enumeration; thence along the northerly right-of-way line of
- 9 State Highway Route 57, N. 49 degrees 44 minutes W. for a
- 10 distance of 147.05 feet to a point, thence by a curve to the
- 11 right, having a radius of 11,429.19 feet for a distance of
- 12 162.91 feet, to a point, thence N. 48 degrees 55 minutes W. for
- 13 a distance of 494.39 feet to a point, offset northeasterly, at
- 14 90 degrees to and 30 feet from the center line of State Highway
- 15 Route 57, at Station 1027/02.87, of the State Highway Straight
- 16 Line Diagram Enumeration; thence along lands of N/F Chester D.
- 17 and Gussie M. Bailey, N. 29 degrees 20 minutes E. for a distance
- 18 of 204.30 feet, to a point; thence along lands of Robinson Clay
- 19 Products Company N. 29 degrees 20 minutes E. for a distance of
- 20 163.6 feet, to a point, offset southwesterly, at 90 degrees to
- 21 and 33 feet from, the center line of the Pennsylvania Railroad
- 22 Company; thence along the southerly right-of-way line of the
- 23 Pennsylvania Railroad Company by a curve to the right, having a
- 24 radius of 2831.93 feet, for a distance of 733.57 feet, to a
- 25 point, thence S. 24 degrees 51 minutes E. for a distance of
- 26 257.79 feet to a point, offset southwesterly at 90 degrees to
- 27 and 33 feet from the center line of the Pennsylvania Railroad
- 28 Company; thence along lands of Pennsylvania Department of
- 29 Transportation, acquired for an unobstructed view January 16,
- 30 1936, S. 85 degrees 36 minutes 30 seconds East for a distance of

- 1 71.02 feet, to the point of beginning, containing 4.27 acres
- 2 more or less; reserving a right-of-way 50 feet in width for the
- 3 County Road leading to the N/F Clearfield County Home.
- 4 BEING the same premises the Clearfield County Institution
- 5 District conveyed to the Commonwealth of Pennsylvania, by deed
- 6 dated April 13, 1953 and recorded in Deed Book 428, Page 280, at
- 7 the Clearfield County Courthouse, in the Borough of Clearfield,
- 8 Clearfield County.
- 9 Section 3. Requirement for conveyance.
- 10 The conveyance shall be made under and subject to all lawful
- 11 and enforceable easements, servitudes and rights of others,
- 12 including, but not limited to, streets, roadways and rights of
- 13 any telephone, telegraph, water, electric, gas or pipeline
- 14 companies, as well as under and subject to any lawful and
- 15 enforceable estates or tenancies vested in third persons
- 16 appearing of record, for any portion of the land or improvements
- 17 erected thereon.
- 18 Section 4. Deed.
- 19 The deed of conveyance shall be executed by the Secretary of
- 20 General Services in the name of the Commonwealth of
- 21 Pennsylvania.
- 22 Section 5. Proceeds.
- 23 The proceeds from the sale shall be deposited in the Motor
- 24 License Fund and shall be available to the Department of
- 25 Transportation for all duly authorized purposes.
- 26 Section 6. Effective date.
- 27 This act shall take effect immediately.
