AN ACT

- 1 Providing for outpatient psychiatric oversight.
- 2 The General Assembly of the Commonwealth of Pennsylvania
- 3 hereby enacts as follows:
- 4 Section 1. Short title.
- 5 This act shall be known and may be cited as the Outpatient
- 6 Psychiatric Oversight Act.
- 7 Section 2. Definitions.
- 8 The following words and phrases when used in this act shall
- 9 have the meanings given to them in this section unless the
- 10 context clearly indicates otherwise:
- "ADVANCED PRACTICE PROFESSIONAL." A REGISTERED, LICENSED OR <--
- 12 CERTIFIED HEALTH CARE PRACTITIONER WHO HAS GAINED ADDITIONAL
- 13 SPECIALIZED KNOWLEDGE, SKILLS AND EXPERIENCE THROUGH A PROGRAM
- 14 OF STUDY IN THAT SPECIALTY.
- 15 "Department." The Department of Human Services of the
- 16 Commonwealth.

- 1 "Full-time equivalent." Thirty-seven and one-half hours per
- 2 week.
- 3 "Outpatient psychiatric clinic." A nonresidential treatment
- 4 setting in which psychiatric, psychological, social, educational
- 5 and other related services are provided under medical
- 6 supervision. It is designed for the evaluation and treatment of
- 7 individuals of any age with mental illness or emotional
- 8 distress. Outpatient services are provided on a planned and
- 9 regularly scheduled basis.
- 10 "Psychiatrist." A physician who has completed at least three
- 11 years of a residency in psychiatry and is licensed to practice
- 12 psychiatry in this Commonwealth.
- 13 "TELEPSYCHIATRY." THE PRACTICE OF MEDICINE IN THE SPECIALTY <--
- 14 FIELD OF PSYCHIATRY USING ELECTRONIC COMMUNICATIONS, INFORMATION
- 15 TECHNOLOGY OR OTHER MEANS BETWEEN A PROVIDER IN ONE LOCATION AND
- 16 A PATIENT IN ANOTHER LOCATION, WITH OR WITHOUT AN INTERVENING
- 17 HEALTH CARE PROVIDER. THE TERM DOES NOT INCLUDE ANY OF THE
- 18 FOLLOWING:
- 19 (1) AN AUDIO-ONLY, TELEPHONE CONVERSATION.
- 20 (2) AN E-MAIL OR INSTANT MESSAGING CONVERSATION.
- 21 (3) A FACSIMILE TRANSMISSION.
- 22 Section 3. Requirements.
- 23 The following shall apply:
- 24 (1) Except as provided for in paragraph (2), an
- outpatient psychiatric clinic is required to have a
- 26 psychiatrist on site for two hours of psychiatric time per
- 27 week for each full-time equivalent treatment staff member
- employed by the outpatient psychiatric clinic. Telepsychiatry
- 29 provided by a psychiatrist that is not on site with
- 30 prescriptive authority in this Commonwealth may be utilized

- 1 with a service description approved by the department but
- 2 shall not be included in the required psychiatric time
- 3 required under this paragraph.
- 4 (2) Fifty percent of the required on-site psychiatric
- 5 time under paragraph (1) may be provided by other advanced
- 6 practice professionals specializing in behavioral health with
- 7 prescriptive authority in this Commonwealth.
- 8 Section 4. Regulations.
- 9 The department shall promulgate regulations as necessary to
- 10 carry out the provisions of this act.
- 11 Section 5. Effective date.
- 12 This act shall take effect in 60 days.
