5	The General Assembly of the Commonwealth of Pennsylvania
6	hereby enacts as follows:
7	Section 1. Title 61 of the Pennsylvania Consolidated
8	Statutes is amended by adding a section to read:
9	<u>§ 5907. Pennsylvania Interagency Council on Inmate Reentry.</u>
10	(a) EstablishmentThe Pennsylvania Interagency Council on
11	Inmate Reentry is established.
12	(b) MembershipThe council shall consist of the following
13	members:
14	(1) The secretary, or a designee.
15	(2) The Secretary of Community and Economic Development,
16	<u>or a designee.</u>
17	(3) The Secretary of Education, or a designee.
18	(4) The Secretary of Labor and Industry, or a designee.
19	(5) The Secretary of Human Services, or a designee.

1	(6) The Director of Homeland Security, or a designee.
2	(7) The Director of the Pennsylvania Emergency
3	Management Agency, or a designee.
4	(8) The Executive Director of the Pennsylvania Housing
5	Finance Agency, or a designee.
6	(9) The Adjutant General of the Department of Military
7	and Veterans Affairs, or a designee.
8	(10) The victim advocate of the Office of Victim
9	<u>Advocate, or a designee.</u>
10	(11) The Chairman of the Pennsylvania Board of Probation
11	and Parole, or a designee.
12	(12) An elected county commissioner selected by the
13	County Commissioners Association of Pennsylvania.
14	(13) An elected district attorney selected by the
15	Pennsylvania District Attorney's Association.
16	(14) The chairman of the Pennsylvania Commission on
17	Crime and Delinquency, or a designee.
18	(c) QuorumA majority of the members shall constitute a
19	quorum and a vote of the majority of the members present shall
20	be sufficient for all actions.
21	(d) ChairpersonThe secretary or his designee shall serve
22	as the chairperson of the council. A member of the council shall
23	be designated by the chairperson of the committee as vice
24	chairperson and shall preside at meetings in the absence of the
25	chairperson.
26	(e) MeetingsThe council shall meet at the call of the
27	<u>chairperson but no less than six times per year.</u>
28	(f) ReimbursementMembers of the council shall serve
29	without compensation but may be reimbursed for necessary and
30	reasonable expenses incurred in attending meetings of the

3	(g) SupportThe department shall provide staff and
4	administrative support for the council. The council may enter
5	into a memorandum of understanding with the Pennsylvania
6	Commission on Crime and Delinquency for additional necessary
7	support.
8	(h) Duties
9	(1) The council shall examine:
10	(i) Methods of:
11	(A) Improving the process of reentering inmates
12	into the community.
13	(B) Strengthening the educational and vocational
14	skills of inmates while incarcerated.
15	(C) Establishing and implementing effective and
16	consistent reentry plans prior to inmates' scheduled
17	release into the community.
18	(D) Incentivizing employers to hire former
19	inmates through financial or other economic
20	incentives.
21	(ii) The impediments to successful reentry plans,
22	such as the use of employer background checks and
23	statutory and regulatory bars to employment.
24	(2) The council may rely on studies and reports that
25	have already been prepared by other state entities or private
26	organizations in its examination under this subsection.
27	(i) Report to General AssemblyThe council shall submit a
28	report to the General Assembly that provides the results of its
29	examination and findings under subsection (h) and shall file its
30	report with recommendations no later than one year from the
