AN ACT

Amending the act of July 19, 1979 (P.L.130, No.48), entitled "An 1 act relating to health care; prescribing the powers and 2 duties of the Department of Health; establishing and 3 providing the powers and duties of the State Health Coordinating Council, health systems agencies and Health Care Policy Board in the Department of Health, and State Health Facility Hearing Board in the Department of Justice; 7 providing for certification of need of health care providers and prescribing penalties," in licensing of health care facilities, further providing for licensure. 10 The General Assembly of the Commonwealth of Pennsylvania 11 12 hereby enacts as follows: 13 Section 1. Section 806(h)(1), (2), (3) and (4) of the act of 14 July 19, 1979 (P.L.130, No.48), known as the Health Care 15 Facilities Act, added December 22, 2011 (P.L.563, No.122), are 16 repealed: 17 Section 806. Licensure. * * * 18 19 (h) Abortion facilities. --20 The department shall apply the same regulations promulgated under subsection (f) to abortion facilities that 21

- 1 are applied to ambulatory surgical facilities. These
- 2 regulations include classification of the facilities in the
- 3 same manner as ambulatory surgical facilities.
- 4 (2) The department shall apply to abortion facilities
- 5 any other provision of this chapter governing health care
- 6 facilities insofar as they are applicable to ambulatory
- 7 surgical facilities.
- 8 (3) For the purpose of applying the rules applicable to
- 9 ambulatory surgical facilities, all of the following apply:
- 10 (i) The department shall allow the abortion facility
- 11 to request an exception.
- 12 (ii) The request must identify with specificity the
- reasons for which the exception is sought.
- 14 (iii) In considering a petition under this
- paragraph, the department shall apply the same procedures
- and criteria that are applicable to other health care
- 17 facilities.
- 18 (iv) The department shall issue a written
- determination stating the reasons for a decision under
- 20 this paragraph.
- 21 (4) None of the following shall apply to an abortion
- 22 facility:
- 23 (i) The definition of "ambulatory surgical facility"
- in section 802.1.
- 25 (ii) The definition of "ASF--Ambulatory Surgical
- 26 Facility" in 28 Pa. Code § 551.3 (relating to
- definitions).]
