A RESOLUTION

- Designating the month of April 2015 as "Krabbe Disease Awareness Month" in Pennsylvania.
- 3 WHEREAS, Globoid cell leukodystrophy, commonly known as
- 4 Krabbe disease, is an inherited degenerative disorder of the
- 5 central and peripheral nervous systems; and
- 6 WHEREAS, Krabbe disease is one of a group of genetic
- 7 disorders known as leukodystrophies; and
- 8 WHEREAS, Krabbe disease most often affects infants, with
- 9 early infantile onset occurring in the first months of life; and
- 10 WHEREAS, Late-onset Krabbe disease occurs in older children,
- 11 adolescents or adults; and
- 12 WHEREAS, Krabbe disease is characterized by irritability,
- 13 unexplained fever, limb stiffness, seizures, feeding
- 14 difficulties, vomiting, slowing of mental and motor development,
- 15 muscle weakness, spasticity, deafness and blindness; and

- 1 WHEREAS, Symptoms may vary from person to person; and
- 2 WHEREAS, While no cure exists for Krabbe disease, detecting
- 3 it early and beginning treatment before the appearance of overt
- 4 symptoms enables families to access appropriate additional
- 5 testing and supportive care; and
- 6 WHEREAS, Act 148 of 2014 requires hospitals in this
- 7 Commonwealth to screen newborns for Krabbe disease and five
- 8 other lysosomal storage disorders; and
- 9 WHEREAS, Newborn screening leads to early diagnosis and early
- 10 intervention for at-risk infants; therefore be it
- 11 RESOLVED, That the House of Representatives designate the
- 12 month of April 2015 as "Krabbe Disease Awareness Month" in
- 13 Pennsylvania; and be it further
- 14 RESOLVED, That the Commonwealth officially recognize the
- 15 importance of screening for Krabbe disease to ensure access to
- 16 proactive care and early intervention therapies.
