A RESOLUTION

- Designating June 15, 2015, as "Elder Abuse Awareness Day" in Pennsylvania.
- 3 WHEREAS, Older Pennsylvanians should be recognized as a
- 4 valuable resource to this Commonwealth; and
- 5 WHEREAS, No one is immune to the threat of elder abuse; and
- 6 WHEREAS, It is an obligation of all residents to protect the
- 7 health, safety and welfare of this Commonwealth's elder
- 8 residents; and
- 9 WHEREAS, The Commonwealth received more than 20,800 reports
- 10 of elder abuse in 2014, and it is estimated that only one in
- 11 five cases of abuse is reported; and
- 12 WHEREAS, The Department of Aging has declared the theme of
- 13 this year's "Elder Abuse Awareness Day" as One Person, One

- 1 Action, One Nation: United Against Elder Abuse; and
- 2 WHEREAS, The act of November 6, 1987 (P.L.381, No.79), known
- 3 as the Older Adults Protective Services Act, requires that older
- 4 adults who lack the capacity to protect themselves shall have
- 5 access to and be provided with services necessary to protect
- 6 their health, safety and welfare; and
- 7 WHEREAS, A partnership exists between the Department of
- 8 Aging, the Pennsylvania Association of Area Agencies on Aging,
- 9 the Temple Institute on Protective Services, district attorneys,
- 10 county elder abuse task forces and State and local law
- 11 enforcement to investigate every allegation of elder abuse; and
- 12 WHEREAS, It is necessary to increase awareness of the
- 13 incidents of elder abuse and to educate people about the methods
- 14 to report suspected cases of abuse; therefore be it
- 15 RESOLVED, That the House of Representatives designate June
- 16 15, 2015, as "Elder Abuse Awareness Day" in Pennsylvania and
- 17 strive to increase awareness every day about elder abuse and the
- 18 resources in place to prevent it from occurring.
