7 valiantly gave his life in the line of duty at 30 years of age
8 on December 21, 2015, while stationed in Afghanistan; and

9 WHEREAS, A native of Wyncote, Pennsylvania, Staff Sergeant
10 Taub was a 2004 graduate of Cheltenham High School; and

11 WHEREAS, Staff Sergeant Taub served with honor and
12 distinction as a member of the United States Air Force for eight
13 years; and

14 WHEREAS, Prior to his deployment to Afghanistan in October

1 2015, Staff Sergeant Taub was stationed at Ellsworth Air Force
2 Base in South Dakota; and

3 WHEREAS, Staff Sergeant Taub will forever be remembered for
4 serving our country with honor, pride and loyalty and for making
5 the greatest of all sacrifices in defense of the cause of
6 freedom; therefore be it
