## A RESOLUTION

- Honoring the life, memory and public service contributions of Nelson M. Polite, Sr., of the City of Lancaster and extending condolences to his family.
- WHEREAS, Nelson M. Polite, Sr., died surrounded by family on
- 5 February 22, 2016, at 92 years of age in the same North Street
- 6 home in the City of Lancaster where he was born and lived all
- 7 his life except for four years while serving in the United
- 8 States Army during World War II; and
- 9 WHEREAS, A 1941 graduate of J.P. McCaskey High School, Mr.
- 10 Polite was a devoted member of the Bethel African Methodist
- 11 Episcopal Church, serving as chairman of the Elders Board and as
- 12 trustee emeritus; and
- 13 WHEREAS, In 1988, Mr. Polite retired after working 42 years
- 14 as a United States Department of Defense marketing and sales
- 15 manager; and
- 16 WHEREAS, Mr. Polite held public office for 14 years as a

- 1 member of the Lancaster City Council, serving two years as
- 2 council president, and as chairman of the Lancaster City
- 3 Planning Commission for a decade; and
- 4 WHEREAS, Mr. Polite founded the antidrug group DADDS
- 5 (Demonstrating Against Drug Dealers) and was an active leader of
- 6 the Lancaster Branch of the National Association for the
- 7 Advancement of Colored People, Crispus Attucks Community Center,
- 8 Arbor Place Youth Center, Conestoga Elks Lodge, United Way of
- 9 Lancaster County, J.P. McCaskey High School Alumni Association,
- 10 Lancaster Recreation Commission, SouthEast Lancaster Health
- 11 Services and many other organizations; and
- 12 WHEREAS, Following in the footsteps of his father, Abraham,
- 13 who helped found the Lancaster NAACP in 1923, Mr. Polite was a
- 14 civil rights icon who always worked for equality and fairness;
- 15 and
- 16 WHEREAS, In 1947, Mr. Polite formed Boy Scout Troop 15 at a
- 17 time when Boy Scout troops were not open to black children in
- 18 either the City of Lancaster or County of Lancaster; and
- 19 WHEREAS, In the summer of 1963, Mr. Polite helped to lead
- 20 protest marches at the segregated Rocky Springs Park pool and in
- 21 front of downtown Lancaster stores that offered few jobs to
- 22 African Americans; and
- 23 WHEREAS, After the 1968 assassination of Dr. Martin Luther
- 24 King, Jr., Mr. Polite walked the streets to urge calm; and
- WHEREAS, As a member of the Mount Horeb Lodge No. 14, Mr.
- 26 Polite was elevated to the 33rd and last degree in the Ancient &
- 27 Accepted Scottish Rite of Freemasonry in 1975, and served many
- 28 leadership roles, including vice president of the Statewide
- 29 Masonic organization and 68 years as a Prince Hall Mason; and
- 30 WHEREAS, When asked in 2015 what he would like his legacy to

- 1 be, Mr. Polite replied, "I want people to say Nelson Polite was
- 2 a good and useful person and he tried to do the best he could
- 3 for his neighborhood"; and
- 4 WHEREAS, A well-respected and strongly admired community
- 5 leader, Mr. Polite is deeply missed by all who knew him; and
- 6 WHEREAS, Mr. Polite, whose wife, Jean, died in 2004 after 54
- 7 years of marriage, is survived by their children, Deborah,
- 8 Nelson Jr., and Patrice, 12 grandchildren and many great-
- 9 grandchildren; therefore be it
- 10 RESOLVED, That the House of Representatives honor the life,
- 11 memory and public service contributions of Nelson M. Polite,
- 12 Sr., of the City of Lancaster and extend condolences to his
- 13 family; and be it further
- 14 RESOLVED, That a copy of this resolution be transmitted to
- 15 the family of Nelson M. Polite, Sr.
