18	hereby enacts as follows:
19	Section 1. The act of March 20, 2002 (P.L.154, No.13), known
20	as the Medical Care Availability and Reduction of Error (Mcare)
21	Act, is amended by adding a section to read:
22	Section 5103.2. Mcare Commission.
23	(a) EstablishmentThere is established the Mcare
24	<u>Commission.</u>
25	(b) CompositionThe Mcare Commission shall consist of the

1	following members:
2	(1) One member appointed by the Governor.
3	(2) One member appointed by the President pro tempore of
4	the Senate.
5	(3) One member appointed by the Minority Leader of the
6	Senate.
7	(4) One member appointed by the Speaker of the House of
8	Representatives.
9	(5) One member appointed by the Minority Leader of the
10	House of Representatives.
11	(6) Three members of the medical community in this
12	Commonwealth, appointed by the Governor from individuals
13	formally recommended by the Pennsylvania Medical Society.
14	(7) Two members who are hospital administrators in this
15	Commonwealth, appointed by the Governor from individuals
16	recommended by the Hospital and Healthsystem Association of
17	<u>Pennsylvania.</u>
18	(8) One student, who is a resident of this Commonwealth,
19	from an accredited medical college located in this
20	Commonwealth.
21	(c) Powers and dutiesNotwithstanding this act or any
22	other law and on and after the effective date of this section,
23	the commission shall review all funding which emanates from the
24	Medical Care Availability and Reduction of Error (Mcare) Fund.
25	No funding shall emanate from the fund unless approved by a
26	majority of the commission.
27	Section 2. This act shall take effect in 60 days.
