AN ACT

- 1 Amending the act of December 20, 2000 (P.L.724, No.99), entitled
- 2 "An act requiring purchasers of real estate with buildings
- thereon to bring the buildings into compliance with municipal
- 4 codes; providing for nuisance abatement; and imposing
- 5 penalties," further providing for compliance requirement.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Section 3(a) and (e) of the act of December 20,
- 9 2000 (P.L.724, No.99), known as the Municipal Code and Ordinance
- 10 Compliance Act, are amended and the section is amended by adding
- 11 a subsection to read:
- 12 Section 3. Compliance requirement.
- 13 (a) General rule. -- Within [18] 12 months of the date of
- 14 purchase or longer subject to an agreement between the purchaser
- 15 and the municipality, any purchaser of any building, structure
- 16 or part of a building or structure known to have one or more
- 17 substantial violations of municipal codes relating to building,
- 18 housing, property maintenance or fire shall:
- 19 (1) bring the building, structure or that part of a

- 1 building or structure into compliance with those codes; or
- 2 (2) demolish the building or structure in accordance
- 3 with law.
- 4 * * *
- 5 (d.1) Property maintenance codes. -- Municipalities that have
- 6 adopted a property maintenance code may enforce the provisions
- 7 of the code even if the code requires compliance within a
- 8 shorter period of time than required under subsection (a) or
- 9 <u>(c).</u>
- 10 (e) Coordination with other requirements.--In connection
- 11 with the purchase of a building, structure, part of a building
- 12 or structure, lot or parcel of land subject to subsection (a) or
- 13 (c), a municipality shall not refuse to issue a use and
- 14 occupancy certificate or similar permit on the basis of a
- 15 substantial violation or require the correction of a substantial
- 16 violation as a condition to issuing a use and occupancy
- 17 certificate or similar permit unless the substantial violation
- 18 renders the property unfit for habitation or the municipality
- 19 denies the certificate or permit pursuant to 53 Pa.C.S. Ch. 61
- 20 <u>(relating to neighborhood blight reclamation and</u>
- 21 revitalization).
- 22 Section 2. This act shall take effect in 60 days.
