AN ACT

- 1 Authorizing the Department of General Services, with the
- approval of the Governor, to grant and convey a certain tract
- of land and improvements thereon in Lower Oxford Township,
- 4 Chester County.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Authorization.
- 8 The Department of General Services, with the approval of the
- 9 Governor, is hereby authorized on behalf of the Commonwealth of
- 10 Pennsylvania to grant and convey to Willow Creek, LLC, the
- 11 following tract of land, together with all improvements thereon,
- 12 situate in Lower Oxford Township, Chester County, for \$1,500.00
- 13 and under terms and conditions to be established in an agreement
- 14 of sale.
- 15 Section 2. Description.
- 16 The property to be conveyed pursuant to section 1 consists of
- 17 approximately .030 acres of land and improvements located
- 18 thereon, bounded and more particularly described as follows:
- 19 ALL THAT CERTAIN tract of land with small pump house building

- 1 thereon erected, situate in Lower Oxford Township, Chester
- 2 County, Pennsylvania, being more particularly described as
- 3 follows, to wit:
- 4 BEGINNING at a point set at the southwesterly corner of this
- 5 about-to be-described lease boundary, said point being formed by
- 6 the intersection of lines being 10 feet South and parallel to
- 7 the south wall of the building hereon erected and also by a line
- 8 being 10 feet West of the west wall of the building, said point
- 9 being set the following two courses and distances from a point
- 10 set in the centerline of Public Road T-331 marking a corner of
- 11 land of Arthur Wichart and a corner of Lincoln University: south
- 12 05 degrees 16 minutes West 764.85 feet to a concrete monument,
- 13 North 19 degrees 50 minutes 49 seconds East, 50.96 feet to a
- 14 point being the Place of BEGINNING; thence leaving said Point
- 15 and by other land of Lincoln University, of which this was a
- 16 part, the following courses and distances to wit:
- North 12 degrees 17 minutes East 32.00 feet to a point
- 18 South 77 degrees 43 minutes East 42.00 feet to a point
- 19 South 12 degrees 17 minutes West 32.00 feet to a point
- North 77 degrees 43 minutes West 42.00 feet to a point being
- 21 the Place of BEGINNING.
- CONTAINING .030 acres or 1,344 square feet of land being the
- 23 same more or less;
- 24 BEING PART OF THE SAME PREMISES which Lincoln University, a
- 25 Corporation, by Deed dated March 23, 1971, and recorded in the
- 26 Office of the Recorder of Deeds in and for Chester County,
- 27 Pennsylvania in Book V-39, Page 767, granted and conveyed unto
- 28 The General State Authority. The Department of General Services
- 29 being the legal successor to the General State Authority
- 30 pursuant to Act 45 of 1975.

- 1 Section 3. Easements.
- 2 The conveyance shall be made under and subject to all lawful
- 3 and enforceable easements, servitudes and rights of others,
- 4 including, but not confined to, streets, roadways and rights of
- 5 any telephone, telegraph, water, electric, gas or pipeline
- 6 companies, as well as under and subject to any lawful and
- 7 enforceable estates or tenancies vested in third persons
- 8 appearing of record, for any portion of the land or improvements
- 9 erected thereon.
- 10 Section 4. Covenant.
- 11 The deed of conveyance shall contain the following covenant:
- "Under and subject to the condition, that no portion of
- the property conveyed shall be used as a licensed
- facility, as defined in 4 Pa.C.S. § 1103 (relating to
- definitions), or any other similar type of facility
- authorized under State law. The condition shall be a
- 17 covenant running with the land and shall be binding upon
- the Buyer (Grantee), its successors and assigns. Should
- the Buyer (Grantee), its successors or assigns, permit
- any portion of the property to be used in violation of
- 21 this restriction, the title shall immediately revert to
- and revest in the Seller (Grantor)."
- 23 Section 5. Deed.
- 24 The deed of conveyance shall be by special warranty deed and
- 25 shall be executed by the Secretary of General Services in the
- 26 name of the Commonwealth of Pennsylvania.
- 27 Section 6. Proceeds.
- The proceeds from the sale shall be deposited in the General
- 29 Fund.
- 30 Section 7. Effective date.

1 This act shall take effect immediately.
