3 § 7413. Statement of purpose.

The purpose of this subchapter is to encourage individuals to take part in the fire service as volunteer firefighters by establishing criteria and standards for orderly administration and conduct of affairs of firefighters' relief associations to ensure, as far as circumstances will reasonably permit, that funds shall be available for the <u>assistance to and</u> protection of volunteer firefighters and their heirs in order to provide:

12 (4) Safeguards for preserving life, health and safety of
13 volunteer firefighters to ensure their availability to

10 (b) Findings.--If the Auditor General finds that [any] money received by a volunteer firefighters' relief association has 11 12 been expended for a purpose other than one authorized by this 13 subchapter, the Auditor General shall immediately notify the 14 Governor and shall decline to approve further requisitions 15 calling for payment to the volunteer firefighters' relief association until the improperly expended amount has been 16 reimbursed to the relief association fund. 17

18 Section 5. This act shall take effect in 60 days.
