AN ACT

- 23 The General Assembly of the Commonwealth of Pennsylvania
- 24 hereby enacts as follows:
- 25 Section 1. Army Specialist Ray Ira Haas Memorial Highway.
- 26 (a) Findings. -- The General Assembly finds and declares as
- 27 follows:
- 28 On March 28, 1968, in the Quang Tri Province, South
- 29 Vietnam, Army Specialist Ray Ira Haas was performing his
- 30 assigned duty as an infantryman on the battlefield.
- During these operations, Army Specialist Haas and 31
- 32 his infantry came under fire.
- 33 Army Specialist Haas fought bravely and was mortally
- 34 wounded during the firefight, later being pronounced dead at
- 35 a hospital in Vietnam.
- Designation. -- That the portion of State Route 663 from 36
- the Bucks County line, through Pennsburg Borough to the end of 37
- Upper Hanover Township in Montgomery County, is hereby 38
- 39 designated the Army Specialist Ray Ira Haas Memorial Highway.
- 40 Signs. -- The Department of Transportation shall erect and
- maintain appropriate signs displaying the name of the highway to 41

- 1 traffic in both directions on the highway.
- 2 Section 2. First Lieutenant William Raymond Gendebien Memorial
- 3 Highway.
- 4 (a) Findings. -- The General Assembly finds and declares as
- 5 follows:
- 6 (1) On October 26, 1965, in Quang Nam Province, South
- 7 Vietnam, VMFA 115 was performing combat operations against
- 8 hostile forces.
- 9 (2) First Lieutenant William R. Gendebien was performing
- 10 his assigned duty as Air Traffic Controller from an aircraft
- 11 with the assigned crew in support of VMFA 115 in their combat
- 12 operations.
- 13 (3) During these operations, hostile actions downed the
- 14 aircraft with its crew and it made a crash landing.
- 15 (4) First Lieutenant William R. Gendebien died in the
- 16 crash of the aircraft.
- 17 (b) Designation.--That the portion of State Route 100 from
- 18 Hereford Township at the Lehigh County line through Washington
- 19 Township in Berks County is hereby designated the First
- 20 Lieutenant William R. Gendebien Memorial Highway.
- 21 (c) Signs.--The Department of Transportation shall erect and
- 22 maintain appropriate signs displaying the name of the highway to
- 23 traffic in both directions on the highway.
- 24 Section 3. Private First Class Paul T. Wright Memorial Highway.
- 25 (a) Findings.--
- 26 (1) Private First Class Paul T. Wright was a resident of
- 27 Willow Grove, Pennsylvania, before enlisting in the United
- 28 States Army.
- 29 (2) PFC Wright was assigned to the 3rd Platoon, C
- 30 Company, 26th Engineer Battalion, Americal Division of the

- 1 United States Army in Vietnam.
- 2 (3) While valiantly serving his country, PFC Wright, at
- 3 20 years of age, was killed by an explosive device on April
- 4 3, 1968, in the Quang Ngai Province of South Vietnam.
- 5 (b) Designation. -- The section of State Route 2026, also
- 6 known as Blair Mill Road, in Montgomery County from Easton Road
- 7 to Horsham Road is hereby designated the Private First Class
- 8 Paul T. Wright Memorial Highway.
- 9 (c) Signs.--The Department of Transportation shall erect and
- 10 maintain appropriate signs displaying the name of the highway to
- 11 traffic in both directions on the highway.
- 12 Section 4. Staff Sgt. Jason M. Faley Memorial Bridge.
- 13 (a) Findings.--The General Assembly finds and declares as
- 14 follows:
- 15 (1) Staff Sergeant Jason Matthew Faley was born on May
- 16 19, 1973 and graduated from Red Land High School in 1991.
- 17 (2) He was a Staff Sergeant in the United States Air
- 18 Force, Special Operations Tactical Air Control Party, serving
- with the 5th Special Forces stationed at Fort Campbell,
- 20 Kentucky, supporting the 101st Airborne Forces.
- 21 (3) Staff Sergeant Jason M. Faley was killed in Kuwait
- 22 on March 12, 2001.
- 23 (4) Prior to his death, he received numerous medals and
- 24 commendations including the Air Force Achievement Medal, The
- 25 Army Achievement Medal, the Armed Forces Expeditionary Medal,
- the Airborne Parachutist Badge, the Military Free Fall Badge,
- 27 The Air Assault Badge and the Pathfinder Badge. He was also
- 28 Ranger certified and a graduate of Airman Leadership School.
- 29 (b) Designation. -- The bridge located on Sheep Bridge Road in
- 30 Newberry Township, York County, over I-83 is hereby designated

- 1 the Staff Sgt. Jason M. Faley Memorial Bridge.
- 2 (c) Signs. -- The Department of Transportation shall erect and
- 3 maintain appropriate signs displaying the name of the bridge to
- 4 traffic in both directions on the bridge.
- 5 Section 5. Private David Kyle McCracken Memorial Bridge.
- 6 The General Assembly finds and declares as follows:
- 7 (a) Findings.--
- 8 (1) David Kyle McCracken was born March 12, 1924, to J.
- 9 Ward and Margaret Jane Kyler McCracken of Shawville,
- 10 Clearfield County.
- 11 (2) Mr. McCracken graduated from Clearfield High School
- in 1942 and was employed by the Department of Highways until
- 13 March 1943, when he was inducted into the Army.
- 14 (3) Private McCracken received basic training at Camp
- Walters, Texas, and was sent to North Africa in September
- 16 1943 as a member of the 15th Engineers Combat Battalion, 9th
- 17 Division.
- 18 (4) Private McCracken was later transferred to England,
- 19 Italy, France and Germany.
- 20 (5) On December 31, 1944, Private McCracken made the
- 21 ultimate sacrifice for his country when he was killed in
- 22 action in Belgium.
- 23 (6) Private McCracken is the recipient of a Purple
- Heart.
- 25 (b) Designation. -- The bridge located on State Route 879 over
- 26 Trout Run in Goshen Township, Clearfield County, is hereby
- 27 designated the Private David Kyle McCracken Memorial Bridge.
- 28 (c) Signs.--The Department of Transportation shall erect and
- 29 maintain appropriate signs displaying the name of the bridge to
- 30 traffic in both directions on the bridge.

- 1 Section 6. Cpl. Carl F. Hynek III Memorial Highway.
- 2 (a) Findings.--
- 3 (1) Cpl. Carl Hynek was born and raised in Upper
- 4 Moreland Township, Montgomery County.
- 5 (2) Cpl. Carl Hynek was drafted into the United States
- 6 Army after his high school graduation and served in Vietnam
- 7 with the 101st Airborne Division.
- 8 (3) Cpl. Carl Hynek was killed on October 5, 1967, in
- 9 Quang Nam, South Vietnam, at 22 years of age from wounds he
- 10 received in an intense firefight with enemy forces.
- 11 (b) Designation. -- The section of State Route 2034 in
- 12 Montgomery County from Terwood Road to Moreland Road is hereby
- 13 designated the Cpl. Carl F. Hynek III Memorial Highway.
- 14 (c) Signs.--The Department of Transportation shall erect and
- 15 maintain appropriate signs displaying the name of the highway to

- 16 traffic in both directions on the highway.
- 17 Section 7. Officer Dennis McNamara Memorial Highway.
- 18 (a) Findings. The General Assembly finds and declares as
- 19 follows:
- 20 (1) Officer Dennis McNamara was born July 4, 1958, and
- 21 graduated from West Catholic High School.
- 22 (2) Officer McNamara served in the United States Air
- Force from February 1981 to February 1987 where he developed
- 24 a background in military intelligence and was a linguist in-
- 25 <u>several Middle Eastern languages.</u>
- 26 (3) Officer McNamara joined the Upper Darby Police Force
- 27 <u>in July 1993 where he served for eight years before giving</u>
- 28 <u>his life in the line of duty.</u>
- 29 (4) On January 30, 2002, Officer McNamara was
- 30 investigating a suspicious vehicle and occupant in the

- 1 Cardington Section of Upper Darby before being fatally
- 2 wounded as he exited his vehicle.
- 3 (b) Designation. -- The section of State Route 2005, known as-
- 4 Lansdowne Avenue, Delaware County, from State Road to School
- 5 Lane is hereby designated the Officer Dennis McNamara Memorial
- 6 Highway.
- 7 (c) Signs. The Department of Transportation shall erect and

- 8 maintain appropriate signs displaying the name of the road to
- 9 traffic in both directions on the road.
- 10 SECTION 7. CPL. JOSHUA B. SMITH MEMORIAL HIGHWAY.
- 11 (A) FINDINGS.--
- 12 (1) CPL. JOSHUA B. SMITH WAS BORN ON AUGUST 18, 1985, IN
- 13 TWENTYNINE PALMS, CALIFORNIA, AND A YEAR LATER RELOCATED WITH
- 14 HIS FAMILY TO THE LEHIGH VALLEY AREA.
- 15 (2) CPL. SMITH LIVED IN SALISBURY TOWNSHIP AND WAS A
- 16 2003 GRADUATE OF SALISBURY HIGH SCHOOL WHERE HE LED THE
- 17 SCHOOL'S SOCCER TEAM AS CAPTAIN FOR TWO YEARS.
- 18 (3) IN 2003, CPL. SMITH JOINED THE MARINE CORPS AND WAS
- 19 PROMOTED TO PRIVATE FIRST CLASS UPON GRADUATION FROM PARRIS
- 20 ISLAND, SOUTH CAROLINA.
- 21 (4) AFTER SERVING EIGHT YEARS IN THE MARINE CORPS, CPL.
- 22 SMITH WAS HONORABLY DISCHARGED IN 2011.
- 23 (5) CPL. SMITH WAS AWARDED THE NATIONAL DEFENSE SERVICE
- 24 MEDAL, NAVY MERITORIOUS UNIT COMMENDATION, GLOBAL WAR ON
- 25 TERRORISM SERVICE MEDAL, AFGHANISTAN CAMPAIGN MEDAL, SEA
- 26 SERVICE DEPLOYMENT RIBBON, MARINE CORPS GOOD CONDUCT MEDAL,
- 27 KOREAN DEFENSE SERVICE MEDAL, NATO ARTICLE 5 MEDAL AND THE
- 28 NAVY AND MARINE CORPS COMMENDATION.
- 29 (6) CPL. SMITH RETURNED HOME AND STRUGGLED WITH
- 30 POSTTRAUMATIC STRESS DISORDER AND TRAUMATIC BRAIN INJURY

- 1 UNTIL HE LOST HIS BATTLE ON NOVEMBER 5, 2012.
- 2 (B) DESIGNATION.--THE SECTION OF STATE ROUTE 145 IN
- 3 SALISBURY TOWNSHIP, LEHIGH COUNTY, FROM SEGMENT 40 OFFSET 137 TO
- 4 SEGMENT 40 OFFSET 3051 IS HEREBY DESIGNATED THE CPL. JOSHUA B.
- 5 SMITH MEMORIAL HIGHWAY.
- 6 (C) SIGNS.--THE DEPARTMENT OF TRANSPORTATION SHALL ERECT AND

- 15 KANEOHE BAY, HAWAII; AND
- 16 (2) CPL. FAIRCLOTH WAS BORN IN YORK ON MAY 7, 1988, AND
- 17 GRADUATED FROM MECHANICSBURG AREA HIGH SCHOOL IN 2006; AND
- 18 (3) CPL. FAIRCLOTH JOINED THE MARINE CORPS IN 2006 AND
- 19 WAS DEPLOYED TO IRAQ IN 2008 AND TO AFGHANISTAN IN 2010; AND
- 20 (4) CPL. FAIRCLOTH SERVED AS AN AERIAL OBSERVER AND
- 21 AIRCRAFT MECHANIC THROUGHOUT HIS FIVE-YEAR MILITARY CAREER;
- 22 AND
- 23 (5) FOR HIS EXEMPLARY SERVICE, CPL. FAIRCLOTH WAS
- 24 AWARDED FOUR AIR MEDALS, TWO NAVY-MARINE CORPS ACHIEVEMENT

- 13 PROGRAM AT VALLEY FORGE MILITARY ACADEMY.
- 14 (3) IN 1997, MAJOR TOCZYLOWSKI GRADUATED FROM TEXAS A&M
- 15 UNIVERSITY WITH A DEGREE IN CRIMINAL JUSTICE.
- 16 (4) AFTER DEPLOYMENTS IN GERMANY AND BOSNIA, MAJOR
- 17 TOCZYLOWSKI WAS ASSIGNED TO THE 10TH SPECIAL FORCES GROUP IN
- 18 2003.
- 19 (5) ON NOVEMBER 3, 2005, MAJOR TOCZYLOWSKI MADE THE
- 20 ULTIMATE SACRIFICE FOR HIS COUNTRY WHEN HE WAS KILLED IN A
- 21 FALL FROM A HELICOPTER DURING A COMBAT INFILTRATION IN
- 22 HOSTILE ENEMY TERRITORY IN AL ANBAR PROVINCE, IRAQ.
- 23 (6) MAJOR JEFFREY TOCZYLOWSKI'S LEGACY OF SERVICE LIVES
