AN ACT

- 1 Establishing the Student Volunteer Firefighter Housing Grant
- 2 Program; providing for the powers and duties of the State
- Fire Commissioner; and making an appropriation.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Short title.
- 7 This act shall be known and may be cited as the Student
- 8 Volunteer Firefighter Housing Grant Act.
- 9 Section 2. Definitions.
- 10 The following words and phrases when used in this act shall
- 11 have the meanings given to them in this section unless the
- 12 context clearly indicates otherwise:
- 13 "Commissioner." The State Fire Commissioner of the
- 14 Commonwealth.
- 15 "Eligible student." A student who joins a sponsoring
- 16 volunteer fire company or an emergency medical service company
- 17 and enters into a contractual agreement with the sponsoring

- 1 company under a local program to provide at least the minimum
- 2 amount of service per week in the activities of a sponsoring
- 3 company.
- 4 "Emergency medical service company." A nonprofit chartered
- 5 corporation, association or organization that is located in this
- 6 Commonwealth, is licensed by the Department of Health, is not
- 7 associated or affiliated with a hospital and is regularly
- 8 engaged in the provision of emergency medical services,
- 9 including basic life support, advanced life support services and
- 10 advanced life support squads under 35 Pa.C.S. Ch. 81 (relating
- 11 to emergency medical services system). The term does not include
- 12 a corporation, association or organization that is primarily
- 13 engaged in the operation of invalid coaches intended for the
- 14 routine transport of persons who are convalescent or otherwise
- 15 nonambulatory and do not ordinarily require emergency medical
- 16 treatment while in transit.
- 17 "Full-time basis." As defined in 22 Pa. Code § 121.1
- 18 (relating to definitions), except for purposes of the Federal
- 19 Stafford Loan and Federal PLUS Loan Programs.
- 20 "Grant program." The Student Volunteer Firefighter Housing
- 21 Grant Program established by this act.
- "Institution of higher education." As defined in section
- 23 2301-A of the act of March 10, 1949 (P.L.30, No.14), known as
- 24 the Public School Code of 1949.
- 25 "Invalid coach." A vehicle which is primarily maintained,
- 26 operated and intended to be used for routine transport of
- 27 persons who are convalescent or otherwise nonambulatory and do
- 28 not ordinarily require emergency medical treatment while in
- 29 transit. The vehicle shall not be considered an ambulance or
- 30 emergency medical services vehicle.

- 1 "Local program." A program established by a volunteer fire
- 2 company or an emergency medical services company to:
- 3 (1) Construct or renovate a facility to house eligible
- 4 students.
- 5 (2) Enroll and enter into contractual agreements with
- 6 students.
- 7 (3) House eligible students.
- 8 (4) Monitor and enforce eligible students' compliance
- 9 with the provisions of the contractual agreement.
- "Sponsoring company." A volunteer fire company or an
- 11 emergency medical services company that has established a local
- 12 program.
- "Student." A student who is a resident of this Commonwealth
- 14 and enrolled at an institution of higher education on a full-
- 15 time basis.
- 16 "Volunteer fire company." A nonprofit chartered corporation,
- 17 association or organization located in this Commonwealth that
- 18 provides fire protection or rescue services and may offer other
- 19 voluntary emergency services within this Commonwealth. Voluntary
- 20 emergency services provided by a volunteer fire company may
- 21 include voluntary emergency medical services.
- 22 Section 3. Grant program.
- 23 (a) Establishment. -- The Student Volunteer Firefighter
- 24 Housing Grant Program is established and shall be administered
- 25 by the commissioner.
- 26 (b) Purpose of grants. -- Grants may be awarded to sponsoring
- 27 companies for the purpose of constructing or renovating
- 28 facilities owned by the sponsoring fire company as housing units
- 29 for students in order to increase student membership in
- 30 sponsoring companies to maintain and improve the current level

- 1 of firefighting and rescue services and emergency medical
- 2 services.
- 3 (c) Applications. -- A sponsoring company must submit an
- 4 application to the agency for a grant in a manner and a form to
- 5 be established by the commissioner. The application shall
- 6 include a certificate of occupancy issued for the housing units
- 7 and a written copy of the local program.
- 8 (d) Contents of local program. -- A local program shall
- 9 contain all of the following:
- 10 (1) A sufficiently detailed description of the
- 11 construction and renovation of the facility, including
- 12 compliance with relevant Federal, State and local building
- 13 codes.
- 14 (2) A requirement that an eligible student has completed
- and received certification from either:
- 16 (i) the Pennsylvania Fire Academy, or one of its
- delegated authorities, for Firefighter I, II or III, Fire
- 18 Officer I or II or Fire Instructor I or II; or
- 19 (ii) the Department of Health, for certification as
- an emergency medical technician.
- 21 (3) A contractual agreement in which a student agrees
- 22 to:
- 23 (i) become a member of the sponsoring company prior
- 24 to occupation of the provided housing and remain a member
- of the sponsoring company during the entire period of
- time the student occupies the provided housing;
- 27 (ii) participate in the function of the sponsoring
- company during each semester, any agreed-upon service
- during vacation periods and other periods between
- 30 semesters;

- 1 (iii) comply with the requirement for providing
- 2 certain types of service and a minimum number of hours of
- 3 service, that on average equals 30 hours per week, and
- 4 any conditions for any time extension or modification of
- 5 the type of service, as determined by the agreement;
- 6 (iv) pay an amount equal to the total value of the
- 7 services, as determined by the agreement, in the event
- 8 that the eligible student does not provide the types and
- 9 minimum number of hours of service, contained in the
- 10 agreement; and
- 11 (v) at the end of the school year and any additional
- 12 time periods as set forth in the agreement, cooperate
- with the sponsoring company in a review of the nature and
- 14 hours of service rendered by the eligible student by the
- sponsoring company to determine compliance with the
- 16 minimum service requirement.
- 17 (4) A description of the remedies and procedures
- 18 contained in the agreement whereby the sponsoring company may
- 19 seek to recover the value of the hours of service not
- 20 provided by an eligible student, including any time
- 21 extensions for complying with the service requirements.
- 22 (5) A description of the manner in which the value of an
- 23 hour of service is determined.
- 24 (6) A copy of a sample contractual agreement.
- 25 (7) Any other information determined to be necessary by
- the commissioner.
- 27 Section 4. Award of grants.
- 28 (a) General rule. -- The commissioner may approve a grant
- 29 award to a sponsoring company for the purposes of funding
- 30 construction of a new facility and renovation of an existing

- 1 facility owned by the sponsoring company for the housing of
- 2 eligible students.
- 3 (b) Second grants. -- A sponsoring company shall be eligible
- 4 to apply for and receive one grant under the grant program. An
- 5 application from a sponsoring company for a second grant to
- 6 expand its local program may be submitted in any year following
- 7 the year when the initial grant was received and shall require
- 8 an additional showing to the satisfaction of the commissioner
- 9 that the initial grant received by the sponsoring company
- 10 achieved the goals for improved firefighting, rescue services or
- 11 emergency medical services, as stated in the local program.
- 12 (c) Amounts.--
- 13 (1) The maximum amount of a grant shall not exceed
- \$50,000. The total amount of grants awarded per fiscal year
- 15 shall not exceed \$2,500,000.
- 16 (2) If the applications for a grant exceed the total
- amount of funding for the program, the amount of the grant
- shall not be reduced pro rata, and the total number of grants
- awarded shall be accordingly reduced.
- 20 (d) Local program required. -- The commissioner may award a
- 21 grant only to a sponsoring company that has established and
- 22 submitted to the commissioner a local program with its
- 23 application.
- 24 (e) Use of grant. -- A grant awarded under this act shall be
- 25 used for the purposes authorized by this program.
- 26 Section 5. Reports.
- 27 (a) Duty of sponsoring companies.--
- 28 (1) A sponsoring company that receives a grant shall
- 29 submit an annual report for two consecutive years following
- 30 the receipt of the grant. The initial annual report shall be

- 1 submitted one year following the receipt of the grant and on
- 2 that date for the two subsequent years.
- 3 (2) The annual report shall include such information as
- 4 the commissioner deems necessary to determine the
- 5 effectiveness of the grant program and shall include the
- 6 number of eligible students who participated, the number of
- 7 students who did not comply with the minimum service hour
- 8 requirements and the measures undertaken by the sponsoring
- 9 company.
- 10 (b) Duty of commissioner. -- The commissioner shall prepare
- 11 and submit a report to the General Assembly by September 30,
- 12 2022, on the level of participation by sponsor companies, the
- 13 level of participation by eligible students, the effectiveness
- 14 of the program to maintain and increase the number of volunteer
- 15 fire company members and volunteer emergency medical service
- 16 company members and the overall operation of the program. The
- 17 report shall include a statement as to whether the commissioner
- 18 recommends reenactment of the grant program.
- 19 Section 6. Publication and notice.
- The commissioner shall file notice of the grant program's
- 21 availability through the Legislative Reference Bureau for
- 22 publication in the Pennsylvania Bulletin:
- 23 (1) within 90 days of the effective date of this section
- for the fiscal year beginning July 1, 2016; and
- 25 (2) by August 8 for fiscal years beginning after June
- 26 30, 2017.
- 27 Section 7. Appropriation.
- 28 (a) General rule. -- The sum of \$12,500,000 is hereby
- 29 appropriated from the General Fund to the Office of the State
- 30 Fire Commissioner to carry out the purposes of this act.

- 1 (b) Continuing nature. -- This appropriation shall be a
- 2 continuing appropriation and shall not lapse until the close of
- 3 the fiscal year on June 30, 2021, when the remaining unspent and
- 4 unencumbered funds shall lapse back to the General Fund.
- 5 (c) Restriction on use. -- No money from the appropriation for
- 6 grants shall be used for expenses or costs incurred by the
- 7 commissioner for the administration of the grant program under
- 8 this act.
- 9 Section 8. Regulations.
- 10 The commissioner shall:
- 11 (1) Promulgate regulations necessary to carry out the
- 12 purposes of this act.
- 13 (2) Upon completion of at least one public hearing,
- 14 publish interim regulations to carry out the purposes of this
- act within 90 days of the effective date of this section. The
- interim regulations shall not be subject to the act of
- 17 October 15, 1980 (P.L.950, No.164), known as the Commonwealth
- 18 Attorneys Act, or the act of June 25, 1982 (P.L.633, No.181),
- 19 known as the Regulatory Review Act. The interim regulations
- shall expire 18 months following the effective date of this
- 21 section or when final regulations are promulgated, whichever
- occurs first. Final regulations shall be promulgated no later
- 23 than 18 months following the effective date of this section.
- 24 Section 9. Expiration of authority.
- 25 The authority of the commissioner to award grants under this
- 26 act shall expire June 30, 2021.
- 27 Section 10. Effective date.
- This act shall take effect July 1, 2017, or immediately,
- 29 whichever is later.
